14. Applicant shall pay the requisite application fee, as well as the sewer allocation reservation fees and connection fees, if applicable, as provided for in the Franklin Borough Ordinances.
15. Certification from the Tax Collector that all taxes and assessments are paid and up to date.
16. Applicant shall provide any other items deemed necessary by the Board of Public Works.

Approval of this application is contingent upon availability of gallonage as well as the applicant's compliance with all applicable statutes, ordinances and regulations.

The Borough specifically and expressly reserves the right to withdraw the entire allocation in the event the Sussex County Municipal Utilities Authority ("SCMUA") limits or in any way diminishes the Borough's total allocation of effluent. In the event the Borough withdraws the allocation, the Borough will refund all monies paid for the purchase of the allocation. **THE APPLICATION FEE IS NON-REFUNDABLE UNDER ANY CIRCUMSTANCES.**

Upon approval of this application by the Franklin Board of Public Works and the Franklin Borough Council, the applicant agrees to obtain all necessary permits from the Franklin Municipal Construction Office prior to the start of any construction or installation; to pay all applicable municipal charges for permission to open the streets; and to protect all persons from injury caused by unprotected streets or open ditches.
