**ORDINANCE #3-2011**

**NOW THEREFORE BE IT ORDAINED** by the Borough of Franklin, County of Sussex, State of New Jersey that the Code of the Borough of Franklin is hereby amended as follows:

**Section 1.**

Section 56-1G of the Code of the Borough of Franklin is hereby modified as follows [the remaining sections of 56-1 shall not be modified]:

G. The application for employment form, obtained at the office of the Borough Clerk, shall be completed by all persons applying for positions with the Borough. Unless, expressly set forth in the Code of the Borough of Franklin, there shall be no restrictions preventing non-residents from applying for any position in the Borough of Franklin.

**Section 2.**


All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.
