

**BOROUGH OF FRANKLIN

ORDINANCE # 10-2014**

**AN ORDINANCE TO MANDATE DIRECT DEPOSIT
FOR MUNICIPAL EMPLOYEES
PURSUANT TO C. 52:14-15f *et. seq.***

WHEREAS, P.L. 2013 c. 28, authorizes local governments to mandate direct deposit for Certain governmental employees effective July 1, 2014, and;

WHEREAS, P.L. 2013 c. 28 permits governing bodies to grant exemptions on such terms and conditions as they deem necessary.


NOW THEREFORE, BE IT ORDAINED, by the Borough of Franklin, located in Sussex County, State of New Jersey according to the following:

- Section 1. All full time and part time employees and elected public officials who receive compensation from the Borough of Franklin are mandated to have direct deposit of their compensation as of July 30, 2014 in accordance with Chapter 28 P.L. 2013, as defined under C.52:14-15f (b).
- Section 2. Seasonal employees who are employed by the Borough of Franklin are exempt from the direct deposit mandate.
- Section 3. Municipal employees may request, in writing, an exemption from the direct deposit mandate to the Borough of Franklin's, CFO, Monica Miebach. Such requests will be presented to the Borough of Franklin within a month. The Borough of Franklin may grant such an exemption by resolution and only for good cause.
- Section 4. If any Section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the Section, paragraph subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- Section 5. All ordinances or parts of ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
- Section 6. This Ordinance shall take effect July 8, 2014 after final passage, adoption and publication according to law.


