ORDINANCE # 12-2016
AMBULANCE CAPITAL PURCHASES**

AN ORDINANCE APPROPRIATING THE SUM OF \$20,000.00 FROM RESERVE FOR AMBULANCE EQUIPMENT BY THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY.

BE IT ORDAINED AND ENACTED by the Mayor and Council of the Borough of Franklin, County of Sussex, New Jersey, as follows:

SECTION 1: The sum of Twenty thousand dollars (\$20,000.00) to be utilized out of the Reserve for Ambulance Equipment, is hereby appropriated for the following purpose:


For the purchase of a Power Gurney.

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Borough makes the following determination:


- (a) The purpose described in Section 1 hereof is not a Current Expense and is an improvement, which the Borough of Franklin may lawfully make as a Current Capital Improvement.
- (b) The period of usefulness of the purpose described in section 1 hereof is not in the limitations of the said Local Bond Law and according to the aggregate reasonable life thereof is five (5) years.

SECTION 3: All ordinances or parts of ordinances, which are inconsistent with the terms of this ordinance, be and the same is hereby-repealed to the extent of their inconsistency.

SECTION 4: This ordinance becomes effective immediately upon final passage, approval, and publication as provided by law.


