AN ORDINANCE MODIFYING AND AMENDING THAT SPECIFIC PORTION OF THE FRANKLIN BOROUGH ORDINANCES PERTAINING TO FEES FOR LIQUOR LICENSES AT CHAPTER 119 "GENERAL FEES," Code of the Borough of Franklin §119-4

WHEREAS, the Franklin Borough Mayor and Council, in consultation with the Borough's Planning Board, finds and declares that it is in the best interests of the residents and the Borough to adjust certain liquor licensing fees as more specifically discussed in the proposed ordinance modifications noted herein; and

WHEREAS, Franklin Borough desires to amend and/or replace certain specific fee requirements under the Code of the Borough of Franklin §119-4 in referenced to Chapter 81-7(D)1 Liquor licenses, as more specifically stated below;

NOW, THEREFORE, BE IT ORDAINED by the Franklin Borough Mayor and Council amend and replace that portion of the Borough Code as follows with [bracketed text] representing new, added language and strikethrough-text representing deleted text as follows:

§ 81-7D(1) Liquor licenses:

Plenary retail consumption ~~\$1,045~~ [\$1,254]


Plenary retail distribution \$550 [\$660]




