**AN ORDINANCE AMENDING CHAPTER 176 OF THE CODE OF  
THE BOROUGH OF FRANKLIN,  
THE "MOBILE HOME" ORDINANCES**

**WHEREAS**, the Franklin Borough Mayor and Council desire to amend Chapter 176 "Mobile Homes" of the Code of the Borough of Franklin as it relates to the maximum number of sites within a mobile home park.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Franklin, in the County of Sussex and State of New Jersey as follows:

**Section 1. Licensing Mobile Home Parks** is amended as follows:

Section 176-2, General Requirements, subsection C, is amended to replace "191" with "210".


**Section 2. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Section 4. Effective Date.** This ordinance shall take effect after publication and passage according to law.


