The Administrator gave his report which is on file in the Clerk's office.

Mayor Crowley reported that October is Breast Cancer Awareness Month and the Girl Scouts hung pink ribbons. There was an emergency expenditure of \$16,000.00 for the well repair. This shows how fragile the infrastructure is. Franklin Village is asking for a TWA so that they can move forward on development. The Mayor felt that the request to adopt a resolution from the Highlands Council was political and the voters should decide. The Franklin Senior Housing had their grand opening which was attended by Senator Oroho and Assemblyman Chiusano. The Mayor reported that twenty units are occupied.

OPEN PUBLIC SESSION

Mr. Snyder made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Limon. All were in favor.

Joanne Tatka of 151 Maple Road - The Mayor thanked her and the Girl Scouts for putting up the ribbons up for Breast Cancer Awareness Month. Ms. Tatka questioned the police salaries on the salary ordinance; some were more than 3 %. The Administrator explained that some are higher, and include stipends. He explained that the figures are only for 2009. She did not feel that giving up the four court dates made a difference. The Administrator expressed that every day and hour has a monetary value. She asked how much was saved by not going into arbitration. The Administrator said that there was no way to know. She asked if the Borough hires at the same rate that an employee who left a position? She wanted to know why you cannot hire at \$8.00 - \$9.00 per hour. She questioned why Franklin Senior Housing does not pay taxes. The Mayor stated that they pay in lieu of taxes. The Administrator stated that a set fee is paid on an escalating scale. The Borough gets the entire amount. They have a government subsidized loan. The pilot runs for 15 years and then goes on the tax rolls. They have their own dumpsters for trash. She wanted to know if no feeding of geese was being enforced. The Administrator said that he has instructed Mr. Gunderman, CPWM; if he sees anyone feeding the geese to call the police.

Mike Krupa of 134 Main Street, questioned the police step one of \$7000.00 to \$8000.00. The Mayor said that was part of the negotiations. Mr. Kruppa thought that the raises were exuberant. The Mayor explained that is the going rates of the towns around.

There being no one else present who wished to address the Governing Body, <u>Mr. Limon</u> made a motion to close the meeting to the public, seconded by <u>Mr. Zschack.</u> All were in favor.
