Mr. Limon reported that the Halloween events went very well. He thanked the Mayor and the Recreation Commission for all that they had done.

Mr. Snyder discussed the step increase request from one of the DPW employees. His last increase was in 2005, step 9 was requested, the committee recommended step 8, the current hourly rate is \$20.03 and the new rate would be \$22.20 per hour.

Attorney Ursin reported that the Beazer settlement included a back up well. The Borough needs the back up well and an agreement has been reached for the Borough to drill and do the permitting of the new backup well. There will be an extension of an additional three years to file a site plan. A lien will be filed against the property and the DEP permitting process can begin within the Boroughs time table.

## Indian Ridge Agreement

Richard Wolak, Administrator gave his report which is on file in the Clerk's office. Mr. Wolak reported the repairs to Maple Road were completed and the Borough saved over \$5000.00 with an outside contractor. The DPW almost completed repairs at the pistol range. The Main Street signs that were ordered will be in soon and put up. He discussed the projected SCUMA rate schedule and increase of \$200,000.00 for treatment. This could result in a 6-8 cent increase in the municipal tax rate for 2010. He discussed the debt service of SCUMA which is about 45%-50% of operating costs. SCUMA might lose state aid next year. The Council discussed that the towns affected should get together on this.

The Mayor reported that he went to the firehouse for the Halloween Parade. The Boy Scouts and Franklin Band helped with the festivities. He discussed the incident Monday night at Precision Propane. Residents were evacuated to the firehouse. The State Fire Marshall will be inspecting the site. The Police command vehicle worked well. The OEM was at the scene and did a nice job.

## <u>Discussion 2009 Municipal Capital Improvement Budget</u>

A discussion was held regarding the 2009 Municipal Capital Improvement Budget. The Council discussed capital purchase of a new video recording system for the police cars, the Fire Department purchasing five sets of turnout gear and two additional air packs and bottles.

Mr. Rome explained the levy cap to the Council and public.

Mr. Snyder informed the Council that the committee looked at everything.

The Council also discussed capital improvements to various streets and sidewalks including repairs to the municipal building parking lot. The improvements include repair of the Main Street wall at High Street, sidewalks at the Senior Center and Hemlock Drive, resurfacing of Evans Street and Maple Road and replacing guiderails on Taylor Road. Also included is the purchase a dump truck for DPW, a plow, spreader and hydraulics.

There was a discussion on a grant that was available from the Elections Board for improvements to polling places for ADA compliance which includes ramps, sidewalks, signs and lighting.

Mr. Rome explained the debt ration to all those present. It is a quarter of 1%. The total outstanding debt is one million three.
