He let everyone know that the Borough is getting ready for re-organization by interviewing engineering and auditing firms. He also explained that if the Borough does change firms it is not for reasons of performance, but for economic reasons.

Mr. Wolak's report is on file in the Clerk's Office. He briefly discussed the capital improvement ordinance's that are on tonight's agenda. He stated that all the projects will be reviewed closely to see if they need to be completed at this time.
