Mr. Kulsar reported that Recreation will be having a special meeting for the concession stand.

Mr. Zschack reported that the finance committee met with the department heads and most of the budgets have no increases.

Ms. Miller reported that they are working on making revisions to the new Administrators contract since it is a combined contract. They are working on possibly combining DPW and BPW due to early retirements.

PAGE TWO OF THE MINUTES OF FEBRUARY 8, 2011

Mr. Giordano reported that he spoke to recreation commission about ice skating, they gave him an answer of no because they are concerned about the liability.

Ms. Gardell reported that garbage will be discussed at the BPW meeting. The borough received a DOT grant for 150,000.00 for Master Street.

The Administrator gave his report which is on file in the Clerk's office. He also discussed that the Borough has used 808 tons of salt so far this winter with a cost of \$44,000.00.

<u>The Mayor</u> reported that the Borough received a steamer for the Senior Center from the Catholic Charities. He mentioned that COAH and Pension bills are being worked on at the legislative level.

Mr. Zschack made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Giordano. All were in favor.

Dan Crum of 3 Highpoint asked if the Administrators contract is not ready. Why was the comment period reduced to three minutes? The Mayor said that it was at his discretion. Wanted to know how many retirements will be in 2011? The Mayor stated they are not sure how many. He asked if the Charger was back in service and was answered "no".

Mr. Stender of Church Street questioned the garbage issue. The Mayor said that it is on the agenda tonight.

There being no one else present who wished to address the Governing Body, <u>Mr. Zschack</u> made a motion to close the meeting to the public, seconded by <u>Mr. Giordano</u>. All were in favor.

Mr. Giordano discussed the vouchers that were pulled from the bill list. He asked about the total of \$501.24 for food allowance plus the \$107.00 for pizzas. The Administrator said that it was one person purchasing for all. Mr. Zschack said that this was discussed in the past. He had an issue with two 12 packs of soda, which is a little excessive. He does not believe that the borough should be paying for their food. The Mayor will have the administrator look into this. The Mayor added that this is in the contract.

<u>Discussion on Garbage Bid Specifications</u>

The Council discussed the garbage bid specifications.

Ms. Gardell submitted hand outs with 8 options. She stated that the Board wanted to have many options to see the costs of different options. The survey showed that many residents wanted to keep the current services. If the borough can encourage more recycling then the costs could be reduced. Bulk pickup changes could help reduce costs. She informed the Council of how single stream recycling works and that people would not have to separate recyclables which would help them recycle more. She spoke about the possible changes in the billing process for tipping fees and pass through fees. The cost for the Borough to do its own trash pickup was not recommended because of the cost of trucks, employees, insurance and the trucks being maintained. Some of the Council wanted to further explore Borough trash pickup and felt it could be cost effective.

Approval of Police Car Purchase

Mr. Zschack motioned to approve the police car purchase of a 2011 Dodge Charger stealth package without window tint at a price of \$30,776.00. Seconded by Mr. Kulsar.
