Mr. Zschack stated we asked for five studies; the reason for five studies was to get all five studies and see what is the best action to go with. If we don't have all five studies in front of us how can we decide to go on one of them.

Mrs. Gardell stated in this particular application, there have been costs for the town; attorney fees, planners fees we need to be prudent as to the time we spend on this as a municipality. Mrs. Gardell asked about Area D.

Mr. Kilduff said area D will be on Monday's Planning Board Agenda.

Mayor Crowley commented Area C and Area D will be awhile. There needs to be notice and a public hearing by the Planning Board. Area E has developers that are actively involved with it.

Mr. Zschack stated he still thinks it goes against what the decision was to look at all five areas, decide from those five areas and we are not doing that.

Mr. Kilduff stated at the Council level notice doesn't need to be sent; the properties were already sent notices on the Planning Board level. At the Council level it is different the people that sent letters objecting get noticed after the fact; they have thirty days to object after that. The Council level is different at this point.

Mr. Zshack commented after listening to Mr. Giordano he could change his position and that each site needs to be looked at individually. He could change his position and have this on the agenda the next meeting. Mr. Zshack commented at the hearing we can decide if it is worth deeming it redevelopment.

Mr. Kilduff replied he had conversation with Monica and the Auditor and see how we are doing and if things don't improve we might have to have a spending freeze.

There was a discussion on having additional meetings if needed.
