COMMITTEE REPORTS

Mrs. Gardell reported later this evening there is the ordinance regarding the Commercial Vehicles in a residential zone. Mrs. Gardell encouraged the members of the public to use the public session [for comments]

Mayor Crowley explained it is not until the Ordinance is accepted and Introduced then it becomes a public document. The time to make comments would be at the hearing.

Mr. Giordano reported recreation has a meeting this Wednesday. We are doing movies in the park in October the information will be on the sign with respect to the dates and the movies; flyers will be handed out at the school. Mr. Giordano reported the County Fire Parade is October 5; it is an event everyone should go see.

Mr. Snyder had nothing to report.

Mr. Limon reported he received correspondence from the Police Chief; the Chief has new representation; as a committee we will negotiate his new contract. Mr. Limon commented in that meeting we will also discuss a request from an employee for a salary increase. Mr. Limon stated he will be setting that meeting up.

Mr. Kilduff reported items from the following Administrator's report dated September 24, 2013.

Borough Sites and Street Issues

Preparations are underway for the County Fire Parade on October 5th. The Borough is hosting this year's parade as part of its 100th Anniversary celebration.

Bridge E-06 rehabilitation work is proceeding with demolition of the old work. The historic stone arch will be saved as new steel stringers, sidewalk and paving will be installed to rehabilitate the bridge.

Following complaints brought up at Council meetings, the N.J.D.O.T Region North Maintenance and Operations staff was contacted again regarding a noisy manhole cover on Rt. 23 at Mabie Street. The Administrator has been advised the repaving contract has been closed and this matter is being handled as a maintenance issue.

A letter has been sent to NJDEP again asking the department to close out its file on a leaking heating oil tank at Borough Hall. The tank was removed in 1997. The DEP is seeking funds from the Borough for its Licensed Site Remediation Professional (LSRP) program. This will be costly to the Borough. The Mayor has requested assistance from Senator Oroho.

Financial Control/Legal Issues

The County has just released an amended abstract of ratables for Sussex County municipalities. In Franklin, the total amount of real property exempt from taxation is \$57,681,000. Special deductions for senior, disabled, surviving spouse and veterans total \$52,000.

A memorandum of agreement has been signed with the New Jersey Office of Emergency Management and the Borough as sub grantee for the Federal Emergency Management Agency's Public Assistance and Hazard Mitigation Programs for presidentially declared major disasters. The MOU permits the Borough access to all FEMA records and forms.

The CFO is collecting capital budget requests from department heads for 2013. A meeting with the budget and finance committee is requested for the fourth week of October.

The Borough has taken delivery on a new 2014 Dodge Charger. The vehicle is being outfitted for police patrol use.

Two more surplus vehicles were sold at auction. Two vehicles remain: a 2002 and 2006 Crown Victoria. These vehicles received bids of \$400 and \$700 respectively. No one came forward to complete the transaction. To date the auctions have netted the Borough \$13,034.26 in sales. Operational/Personnel Matters

A draft contract has been prepared for Brian VanDenBroek regarding the Public Works Manger position. It is anticipated this contract will be available for discussion and/or action at the next Council meeting.

Job advertisements have been posted for a replacement part time clerk court attendant. The deadline for applications is September 26th

The Personnel Committee is reviewing wage and salary requests for several employees.

The Police Chief has retained a new representative, Mr. Frank Marcus, to participate in negotiations for the Chief's new contract. The current contract expires at the end of the year.

<u>Land Use Matters</u>
The Planning Board met on September 16th and were advised the ordinance to improve drive thru regulations was defeated by result of a split vote.

The Developer's Agreement with the new owners of Miner's Cove has been filed with the County.

Long-term and Capital Projects

On behalf of the Borough, Harold Pellow & Associates has filed NJDOT local aide grant applications in accordance with the Council's decision to apply for improvement projects for CR631 and High Street. Resolutions in support of these applications are on the agenda.

Two capital ordinances are on tonight's agenda: \$255,000 for improvement of streets and roads and \$20,000 for improvements to the Fire House to enable conversion from oil to gas heat.

Miscellaneous

The Borough extends its sympathies to the family of James DeLac, a former member of the Wallkill Valley First Aid Squad who passed away on September 8, 2013. James's son, Dennis and wife, Barbara are also former squad members.

Mayor Crowley reported the Mineral Show will be held at the school this weekend; he recommended everyone to go. Mayor Crowley commented after 25 years as a crossing guard Mary O'Connell has decided to retire; we wish her luck on her retirement.

Mayor Crowley commented the Firemen Parade is October 5; it is the County Parade and Franklin is celebrating its 100th Anniversary.

Mayor Crowley stated he met with Senator and Assemblywoman McHose Littell this morning, the NJDOT grants were discussed, they will also recommend to DOT these be approved. Mayor Crowley also asked for their help with the NJDEP problems the Borough is having regarding the oil tank that was removed 16 years ago. This oil tank was approved with all the conditions met approved by the Health Department and now the DEP wants to reopen the case which would cost the Borough thousands of dollars to prove everything was done right when it was approved 16 years ago.

Mayor Crowley stated going over the minutes while he was gone it was discussed again about a police hire. Mayor Crowley stated at this point we have approved to hire another patrolman but we keep going around in circles on the process. We have to go forward, we have spent a lot of money in police overtime it needs to come to an end. Mayor Crowley stated he made an executive decision; I'm directing the Administrator to advertise for the position of patrolman and the applications to be returned to the Administrator. When the applications are returned they will be reviewed by myself, the Administrator and the Chief of Police. At that time we will decide whether we have [any] applications that should go forward, if we do, the administrator will sit on the committee for the first round of interviews. If we find anyone that is worthy of coming forth for a second round we will have a background check by the Chief of Police before any further interviews. At that time the second interview by the committee will be done, if a decision is made it will be sent to Council for consideration. If approved that applicant will be notified of conditional employment on the condition that the physical and psychological approvals be finished.

Mayor Crowley stated even though the responsibility of hiring is the Mayor and Council he will tell you right off, any applicant that is not approved by the Chief of Police as far as he is concerned will not go forward. Even though that is not Statute he would say the Chief has almost veto power over the application and the senior police official will be involved in the process.

Mayor Crowley stated we need to go forward to get this done.

OPEN PUBLIC SESSION

Mr. Limon made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Giordano. All were in favor.

Dick Durina, 23 Lozaw Road, Franklin, stepped forward. Mr. Durina asked where the contract stands with the employees of the Board of Public Works, PERC and the Borough of Franklin.

Mayor Crowley explained it is still at PERC; it has not gone further, we are waiting for PERC.

Mr. Durina commented when all is said and done he hopes we didn't spend this much money to save this much money. We have to be careful of legal fees when you attack something like this. Sometimes you have to compromise. One day when this is all said and done he would like to review the legal fees for the last several years on getting this thing done. Mr. Durina commented he is here tonight to beg the Council to settle the contract.

Joe Martinez, 39 Woodland Road, Franklin, stepped forward. Mr. Martinez passed out a hand out to the Council regarding recommendations for the pond area. Mr. Martinez said we formulated a committee with 5 other additional members and we went around the neighborhood asking people in that area what they would like to see.

Mr. Martinez explained the recommendations in the handout to the Council. Some of the recommendations were cameras, repairs to the concession stand, scoreboards, cleaning up the grounds, line painters, softball shed, getting footballs, basketballs and baseballs to loan out at the concession stand.

Mayor Crowley commented we are in open session, what he would like to do is let the Council review this and place this on the next agenda.

Pat Rowett, 36 Rte 23, Franklin, stepped forward. Ms. Rowett asked about the police department having blackberry's to use several years ago.

Mayor Crowley stated a number of years ago the then Chief of Police told the officers they couldn't use cell phone in their cars.

Ms. Rowett asked if there was only one phone in the police department how are they going to text each other.

Mayor Crowley replied by radio.

Ms. Rowett referred to when there was the super storm and tractor trailers were allowed to drive over wires that were down. On Saturday power lines in front of the armory was on fire. She was told it was due to lines being driven over. Ms. Rowett commented to stop drivers from driving over lines in the road.

Jim Marino, 4 Hilltop Lane, Franklin, stepped forward. Mr. Marino asked regarding the reassessment going to be done in Franklin, we are spending \$25,000 to have the entire town reassessed. Mr. Marino commented he imagines the values will be less then what they were because the housing prices have come down. Does that mean his taxes are going to come down.

Mayor Crowley explained the reassessment is to bring the values of the houses in line to the actual values. The only way taxes are going to go down is if you spend

more [less] money as a Borough and don't forget as you should know as a former Councilman, only 30 percent of the tax bill is from the Borough the rest is from the school. Mayor Crowley also explained tax appeals.

Mr. Marino asked about the bond ordinance for repairs on the roads; what is the term.

Mr. Kilduff replied they are one year notes you can roll for 10 years.

Mr. Marino gave his concerns if the repairs would last 10 years.

Mr. Marino stated he sees Mr. Kilduff has commented Elizabethtown Gas regarding gas service to the Borough of Franklin. Have we had any response from them?

Mr. Kilduff stated not yet, he has talked to them on the phone but hasn't heard back from them.

Sean Kidd, 3 Evans Street, Franklin, stepped forward. Mr. Kidd questioned the bond regarding the Firehouse upgrade. Mr. Kidd commented he is a certified energy manager and a senior project manager. Mr. Kidd commented on the cost and recommend the Council to revaluate the bond. Mr. Kidd stated it was a waste of money.

Mayor Crowley suggest Mr. Kidd to call the Administrator.

There being no one else present who wished to address the Governing Body, <u>Mr. Limon</u> made a motion to close the meeting to the public, seconded by <u>Mr. Babcock.</u> All were in favor.

OLD BUSINESS

Mayor Crowley asked what the Borough status was on the wells.

Mr. Kilduff commented last he heard he was waiting for the final paper work from the DEP.

Mayor Crowley asked what was the cost. Mayor Crowley commented there was some paper work in the mayor's office when we had a superfund cleanup several years ago, over on Maple Road and Wildcat. The Federal DEP was suppose to put in a well for the Borough. The paperwork indicates the Borough refused that. He would like to ask the Borough's lawyers if they could find out why the Borough had to pay for that well instead of the Federal DEP paying for it like they said they would; if that decision was made he would like to see if we can appeal that decision. Their original stipulation was they were going to dig a well for the Borough, it has been a number of years but he would like to find out why they didn't make the well, if they can reimburse us if possible.

Mr. McBriar stated they would look into this.
