Mr. Dabinett reported our new public utilities committee met last Thursday, himself, Mr. Snyder and Mr. Rathbun. Some of the items discussed were I & I studies that were done on McCann Street, Mitchell Ave. and the camera study proposed for Rte 23, Franklin Ave. The committee discussed the grant we have in place and grants we are applying for, capital improvements for well and water tanks, road paving for 2016, equipment purchases for 2016, hiring additional employees this year, questioned how much money is left in the 1.6 million dollar bond fund passed in 2014 and at some point the committee would like to look at the fee schedule.

Mr. Dabinett reported as chairman of the ordinance committee we have not had a chance to meet yet, hopefully within the upcoming days we will look and the fee schedules for the Borough.

Mayor Giordano commented the Borough Attorney is working on an ordinance for proposed landlord tenant nuisance, it will be done shortly and referred to you [the ordinance committee].

Mr. Limon reported he is happy to see item number 9 and 12 which is the DPW and FOP contract is on the agenda, he hopes we can ratify that this evening.

Mrs. McHose reported the zoning officer is in the process of sending out letters to the residents of High Street to remind them of the Borough's existing snow removal ordinance. We have an ordinance in place that requires residents who have sidewalks in front of their homes to shovel and clear the sidewalks.

Mrs. McHose commented she did attend the meeting of the Public Utilities Committee, which was very productive. Mrs. McHose commented she met with the Borough attorney, who came here to meet with all the Borough Hall employees and outlined some of our goals. Mrs. McHose commented she is working on a yearend report which she is hoping to give at the January 26, meeting.

Mr. Prol commented it is not really being handed over it is being transferred from one department in the town to another. The record we have here it has 52,452 thousand miles on it.

Mrs. Tatka asked about the cost to the town regarding the Senior Lunch Services.

Mrs. McHose commented there are some costs incurred with having us host the luncheons for residents of Franklin and other towns because we don't just restrict it to Franklin Residents, she doesn't have a breakdown of what the costs are but we do have employees that serve the food and the County does provide us with equipment and the food itself. If you would like the line item breakdown I can get that.

Mrs. Tatka comment she thought they gave a dollar figure in prior years.

Mr. Snyder commented he believes that was \$27,500.

Mr. Prol commented it is \$25,700.

Mrs. Tatka asked what is John Rome's salary now, you said the Borough is saving \$5,000.

Mr. Dabinett commented he believes \$27.01 per hour. Mrs. Tatka asked what the annual salary was with the increase.

Mr. Dabinett commented with the increase it would be roughly \$60 thousand and change.

Mrs. Tatka asked on David Benoit, 29 Auche, did he get a disabled Vet \$250 or for being a Veteran. His wasn't listed.

Mr. Prol commented he is a veteran. Mayor Giordano commented it is a Veteran's Property Tax Deduction.

Mrs. Tatka asked about the DPW contract. Mrs. Mchose commented we did not go over 2% on that one [contract] either.

There being no one else present who wished to address the Governing Body, <u>Mr. Snyder made</u> a motion to close the meeting to the public, seconded by <u>Mr. Martinez.</u> All were in favor.

### **MISCELLANEOUS COMMENTS**

Mr. Snyder commented it was brought up about Corkhill Road paving, there is concern about breaking up of the roadway. Mr. Snyder commented he believes he sees spider [cracks] in the black top already. Did anyone go out and look at that?

Mrs. McHose commented she believes that Tom Knutelsky [did] because the inspector came through the engineers office. Mrs. McHose commented she will follow up with him [Mr. Knutelsky].

There was a brief discussion regarding the paving.

Mr. Martinez asked Mrs. Littell where we stand as far as the track, is that getting ready for bid.

Mr. Dabinett commented the bid specs are ready but they haven't been sent out yet because the track is going to be done in conjunction with the bridge being out and so

forth. It all ties in as far as guard rails being moved and light post being moved, but the bid specs are ready.

Mayor Giordano commented is there any way to coordinate, have the bid spec's sent to the County to try and coordinate that to be done at the same time.

Mrs. McHose commented what we can do is call the County Engineer's office to see when their bids are going out and will double check with Mr. Prol and Mr. Knutelsky.

Mayor Giordano commented it might be a very effective way for us to get a better deal if we piggy back it onto the work that the County is doing.

Mrs. McHose commented we can time it together but she doesn't know about marring them together. Mrs. McHose updated Mr. Prol on the project with bridge E-04. Mrs. Mchose commented what the Mayor is asking is can we coordinate our bid specs on the paving of a path.

Mayor Giordano commented the guard rails in conjunction with the bridge work. They are going to have to be paving the road there anyway.

Mr. Snyder commented what are we going to do with some of these buildings on 23 that haven't been used in a long time and gave examples of some of the properties.

Mrs. McHose commented on a meeting she had with Mr. Drossel and Mr. Prol regarding this matter. Mrs. McHose commented she would check on who owns the properties.

There was a discussion regarding foreclosed and vacant properties around town.

Mr. Martinez asked when will the light at Weis be turned on. Mrs. McHose commented she will check on that with DOT.

Mayor Giordano commented he and Mrs. McHose will be working on a surplus items list we got that in progress. We have asked the department heads if we have surplus goods that we are going to get rid of them. Hopefully we will have the list in the next meeting or two so the Council can authorize them to be surplused off.

Mr. Martinez asked about a break away by Wal-greens and who is responsible now to get that fixed.

Mrs. McHose commented she will check, it didn't bounce back like it was suppose to.

Mr. Martinez commented there is four, there is one missing, so now it is an open way for Washington.

Mrs. McHose commented she will follow up on that with Mr. VanDenBroek.
