Mrs. Tatka commented on there being no guidelines for the Board of Health. Mrs. Tatka commented on the vacant houses behind her house and the new owner doesn't know he has to replace that driveway and explained why and explained people should be made aware of what they need to do before they put money into a house.

Mr. Dabinett commented when they file for permits they should be told what they have to do up there. Mrs. McHose explained the situation with the owner of this property.
