<u>Mayor Giordano</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Dabinett, Ms. Fantasia, Mr. Limon, Mr. Rathbun, Mr. Skellenger and Mayor Giordano.

Absent: Mr. Snyder

Mayor Giordano led the assembly in the flag salute.

Mayor Giordano stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, P.L. 1975, Ch. 231. It has been properly advertised and certified by the Clerk."

COMMITTEE REPORTS

Mr. Limon reported on recreation; there is movie night at the pond 8:00pm this Friday, Carnival tickets are on sale and they have to be purchased on line and before the Carnival starts. Mr. Limon reported the administrator is working on the interviews for the Finance Clerk.

Mayor Giordano commented the closing for the DPW position will be this Friday.

Ms. Fantasia commented last time we took department head recommendations, are we asking for that again, for Brian VanDenBroek to provide us with some type of written recommendation.

Mrs. McHose commented what we have done in the past is she and Mr. VanDenBroek would conduct the interviews and then we usually make a recommendation to the personnel committee and that gets passed on to the full Council. Ms. Fantasia commented she just wants to make sure the department head wishes were being passed along to us.

Mr. Dabinett commented on an email from Mr. Prol concerning the State of New Jersey Hiring Practices. Does that pertain to us and does that pertain to this particular hire?

Mr. Prol commented what he alerted the Council to and the public should be aware that there is proposed regulation in New Jersey that is based on a statue act of seven years ago. It deals with the hiring of public employees in the State of New Jersey. What the proposed regulation seeks to do is give the public a right of comment on those. So, what it would do is now put all employee hires by Municipal/public entities in New Jersey essential through the ordinance process. It is where you go to a first reading then have a public review they could comment. That is not the law right now and it will not be for several months.

Mr. Dabinett reported on Public Works Committee; we had a meeting last Thursday night, our engineer is preparing bid specs for painting the water tank so we can get some idea of what the cost is associated with that. We are also looking for quotes for the I and I repairs of infrastructure for the leeks we have in our sewer mains. We are going to pick one small area award that, let them come in and do the job and if it meets everybody's expectations we will move further with it. There was a brief discussion on I and I. Mr. Deacon is moving ahead with the sewer pumping station over at Sterling Plaza. Mr. Dabinett commented on the email from Mr. VanDenBroek regarding the water meters. Our water meters are old, we are paying individual thousands of dollars to read the meter. Technology has changed, they have the technology now where you can send a car and driver down the street and as they go down the street he is able to read the meters and could probably do the town in seven or eight hours. Mr. VanDenBroek has set up a meeting with one

company for the public works meeting September 7th, they are going to come in and make a presentation.

Mayor Giordano asked about the paving of Buckwheat Road. Mrs. McHose explained we are looking at some time in October.

Mr. Rathbun had nothing to report. Mayor Giordano commented on the new police vehicle and explained.

Mr. Skellenger had nothing to report.

Ms. Fantasia reported on EDC, our next meeting is September 14th, but she does have an update. Mrs. McHose did speak to the owner of where the Bagel Tree is and where Extreme Dance is and their request for signage. He did appear to be interested to address the possibility of a sign in the front. Also, we have a Council meeting on September 12, our next EDC meeting is September 14th, she is asking for the Ordinance committee to meet prior to that so she can go back to that meeting with an update regarding their request in the letter from Stephan Zydon regarding the ordinance on weight restriction on vehicles and the ordinance on auto dealerships being established for primary use instead of secondary use.

Ms. Fantasia reported the finance committee met this evening prior to this meeting we did discuss the antenna situation regarding cell phone providers, we have asked Tom Knutelsky on his expert advice as to how we are going to move forward with that.

Ms. Fantasia reported on the Planning Board meeting. She and the Mayor had to step down for a request of the use variance.

Mrs. McHose commented she was also at the Planning Board, she didn't stay until the end but what she heard from Joyce Carr and David Brady, Esq. this morning was the application is continued and the hearing will continue at the second meeting in September. The Planning Board will be holding at the first meeting in September a public hearing on the Hospital Site Redevelopment Plan and explained. Mrs. McHose commented they did deem the Western Manor Plan Complete they just didn't conclude the hearing by time the meeting ended.

Mrs. McHose commented she is working on the hiring of the finance clerk and the DPW position, she is also working with Mr. VanDenBroek to remediate a bat problem we have in the attic and explained.

Mr. Prol had nothing to report.

Mayor Giordano commented we do have executive session for JCM Investors.

Mr. Prol spoke about the ordinance on the agenda for deputy clerk.

Mayor Giordano commented the fence and DPW garage is complete and looks very nice. Mayor Giordano explained their decision to have a Planning Board Public Hearing on the redevelopment plan for the hospital property. Notices will be sent out to property owners within 200 feet of the property. We want to do the meeting honest and fair, this is another good project for the town. We wanted to make sure it was done right and everyone would have a chance to give their opinions.

Mayor Giordano commented we will have an executive session for JCM Investors which is the property on 517. Tomorrow we will be doing a radio commercial for the Carnival.

Mr. Skellenger thanked the Fire Department for their Lobster Diner they did a fantastic job.

Mrs. Heath asked about number seven on the agenda would that be for negotiations. Mayor Giordano explained item number seven hiring a special labor counsel. There was a discussion back and forth on hiring a special labor counsel.

Mrs. Heath commented one good thing she sees you are going to reinstate the position of deputy clerk. Mrs. Heath commented she believes that position should have never been abolished. Mayor Giordano commented sometimes when you make a mistake a few years down the road you have the opportunity to address that, we are trying to address that mistake and we think it is going to work out for the better. Mrs. Heath invited the Council to the Senior Picnic on September 6th. There was a discussion on the picnic. Mrs. Heath commented she is impressed with Mr. Dabinett on how he keeps on top with all the public works things.

Emily Bazelewich, Mill Street, Franklin, stepped forward. Mrs. Bazelewich asked when they are going to paint the stripes at the end or our street [Mill Street]. Mr. Prol commented we are going to be putting together an ordinance for the painting. Mayor Giordano commented this [the ordinance] will address the parking as well. There was a discussion on having an ordinance. Mrs. Bazelewich commented on the children not wearing helmets while riding their bikes and questioned if the police were giving out tickets for this and the children should be wearing helmets.

There being no one else present who wished to address the Governing Body, Mr. <u>Limon</u> made a motion to close the meeting to the public, seconded by <u>Mr. Skellenger</u>. All were in favor.
