Mayor Giordano led the assembly in the flag salute.

It has been property advertised by posting in Borough Hall, and printed in the New Jersey Herald/Sunday New Jersey Herald on January 5, 2017, and posted on the Borough website, which adequate notice has been certified by the Clerk."

Mayor Giordano commented we do have a presentation but he is going to set that back because we don't have all our recreation member here currently.

# **COMMITTEE REPORTS**

Mr. Rathbun reported he spoke to the Fire Chief Freddie Babcock in reference to LOSAP; for preparation for LOSAP and getting the word out the fire department is making up 25 of the yard signs for around town.

Mayor Giordano commented he believes they are actually splitting that with the WVFAS. Mr. Rathbun commented yes, a total of 50 [signs].

Mayor Giordano commented we are starting negotiations with FOP and we have a new vehicle still waiting to come in.

Mr. Snyder reported on building and grounds; the patch on High Street will be taken care of where we dug out to do some work. The resolution is on tonight in regards to Evans and Main Street, it is a long time coming with a lot of expenditures with that.

Mr. Snyder reported on finance; we had a meeting last Tuesday, Ms. Fantasia will be here shortly, therefore he will give an update on what the meeting was about. The committee talked about water and sewer financials, the new meter to be installed, the antenna lease for T-Mobile/AT&T with the income for 2018, the purchase of the fire truck and the purchase of the ambulance. We went over the current for the financials in the regular budget and the tax sale. We also spoke about the capital budget with the total amount of expenditures for next year.

Mr. Dabinett reported we didn't have a public utility meeting this past Thursday, Mr. VanDenBroek was in Atlantic City for a waste water management course. The Sterling Plaza pumping station is on line after all these months, it has been brought up to date, modernized and it is working at this point in time. In the past we have been talking about making repairs to our sewer mains where we have infiltration; they have gotten quotes from four different contractors to perform that work and explained. When his committee meets he will bring it back to the Council. Mr. Dabinett explained infiltration and the areas to be worked on. Mr. Dabinett reported the road department is working on the snow plowing equipment getting ready for bad weather.

Mr. Limon commented after the finance meeting we had a personnel meeting, we have some updated news Alison is on her way she will update us but some of the items we are talking about in personnel was the deputy clerk, deputy court administrator, update on the second FOP negotiations and we had a resignation

from Planning Board/Recreation secretary. We also received one more resignation that he saw in his email but he will let the Mayor report that.

Mayor Giordano commented to make a note that Mr. Skellenger came at 7:10.

Mr. Skellenger had nothing to report.

Mayor Giordano reported we have the annual Halloween parade which is October 28, this coming Saturday, line up is at 4:00PM and starts at 4:30. After the parade we have a trunk or treat at the Franklin Firemen's Park.

Mayor Giordano reported Mrs. McHose did meet with the FOP which will be discussed in executive session. Mayor Giordano commented two of our employees are leaving first is our Planning Board/Recreation Secretary as said by Mr. Limon. Joyce Carr took a job at the School and congratulations to her.

Mayor Giordano commented the second one he is sad to say but our clerk has decided to leave Franklin, she is leaving for another job and we are all going to miss her. She has done a great job for Franklin for a long time, she has been an unsung hero behind the scenes and a lot of people don't realize. When he was first on the Council we had a lot going on in Borough Hall and we had a couple of people we can count on religiously and Robin Hough was the most, probably the biggest person you could count on, she worked tirelessly when she was here as the Planning Board Secretary and basically any Board that needed help she worked and any time you needed help she came in, she put in extra and she earned the position of Borough Clerk more than anyone he can think of since he has been on Council. She has done a great job for Franklin and is sad to see her go. The door to Franklin is always open.

Mr. Snyder commented he also wishes her the best of luck, he has known Robin for many years, she is very dedicated we are going to miss someone who is dedicated and work ethics that she has had over the course for all these years he has known her. Good Luck.

Mayor Giordano commented Ms. Fantasia arrived it is 7:15.

Mayor Giordano commented the last part of his report is we have some new businesses opening up in town, where Wok N Sushi was is now open it is called Brick and Brew they had a soft opening last night and are open for business tonight. It is fabulous and worth trying and encourages people to check it out.

Mr. Snyder explained to Ms. Fantasia what he had gone over with regards to the finance report.

Ms. Fantasia commented she will defer to what your report was and let the Council and public know that we attend to meet again to go over the same matters we discussed prior to our next meeting when we are all together.

Mrs. McHose commented on Thursday of this week she will have her first meeting with the new bargaining unit, that represents the non-managerial staff for the Borough, DPW has not yet been scheduled she is waiting to hear from them who their representative is and we will get working on that as well. Mrs. McHose commented on her contract she will talk to Mr. Thibault regarding that. Mrs. McHose explained a Local Chamber of Commerce meeting she attended.

Mrs. McHose commented she is very sad to see Robin Hough leave the Borough of Franklin but she wishes her the best in her new venture this is a challenge for her, career wise is a good move and sorry to see her go and appreciates all she has done.

Ms. Fantasia commented she would like a chance to say good bye to Robin as well, she has learned so much from you, you are a professional and it breaks her heart that you are leaving and it is nice to have such a brilliant woman sit up here with her and I will miss you.

Mr. Limon asked was the whole on High Street filled with cement or QP. Mayor Giordano commented didn't know but he trusts the DPW guys know what they are filling it with. Mrs. McHose commented she will check with the engineer who was also involved with this.

Mr. Limon commented he has worked with Robin for a while and enjoyed working with her and hopefully we find someone with her qualifications for in here. Mayor Giordano commented you and Mr. Snyder were on the original Council that hired her.

Mr. Darbee, Esq. from Laddy, Clark and Ryan was filling in for Thomas Prol Borough Attorney. Mr. Darbee had nothing to report.

Mrs. McHose commented she forgot to report on a letter that was from Angelo Bolcato, Esq. It is about Hillside Estates, it is telling everyone that everything has been concluded and he asked her to report this in her administrators report.
