# MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ FEBRUARY 27, 2018

<u>Mayor Giordano</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Ms. Fantasia, Mr. Limon, Mr. Postas, Mr. Rathbun, Mr. Skellenger and Mayor Giordano.

Absent: Mr. Snyder

Mayor Giordano led the assembly in the flag salute.

<u>Mayor Giordano</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been property advertised by posting in Borough Hall, and printed in the New Jersey Herald/Sunday New Jersey Herald on January 5, 2018, and posted on the Borough website, which adequate notice has been certified by the Clerk."

## **COMMITTEE REPORTS**

Mr. Limon commented there was no EDC meeting due to lack of a quorum.

Mr. Postas had nothing to report.

Mr. Rathbun commented the Police Department is here to support the hiring of a new police officer as listed on tonight's agenda.

Mr. Skellenger commented the Planning Board meeting was cancelled, therefore there is nothing to report.

Ms. Fantasia commented the Finance Committee had their final meeting, the Council should have received a detailed budget from the Administrator. Ms. Fantasia explained the various line items and how they will impact the municipal taxes. Ms. Fantasia also commented the Borough is not anticipating much change from last year, we are using a statute that helps keep our reserve for uncollected taxes (RUT number) stable. Ms. Fantasia reported the fund balance was utilized again this year and explained the fund balance. The budget should be introduced on either March 13, 2018 or March 27, 2018. Good financial planning has allowed the Borough to keep our debt ratio the same and be able to establish a reserve for tax appeals. Ms. Fantasia met with Mr. Phil Crabb, Town Historian, they discussed possibly applying for the TAP Grant again to help fund the walking paths down at the pond.

Ms. McHose commented on projects she and the Recreation Commission are working on such as the pond, concession stand and paddle boat and kayak rentals.

Mr. Ursin had nothing to report.

Mayor Giordano welcomed Prosecutor Koch, Freeholder Director John Rose, Freeholder Carl Lazzaro, Freeholder Sylvia Petillo and Freeholder Herbert Yardley. Mayor Giordano stated Franklin Borough received a Grant for \$140,000.00 for the paving of Washington Ave. and School Plaza. Mayor Giordano reported the Spring Fling is on April 14<sup>th</sup> at the American Legion Post at 12:00 noon. Mayor Giordano attended a Franklin Forward Alliance meeting, they are hiring a coordinator and town organizer. The Franklin Forward Alliance involves elected officials, school children and people from the community, it is an exciting program and encourages all to attend a meeting to see what they are all about.

Mayor Giordano stated he will be changing the order of the agenda tonight and go directly to the first item under new business.

## Appointment of Police of Officer

Mr. Rathbun made a motion to appoint Nicholas Della Fera to the Franklin Borough Police Department starting at step 1 as per the FOP contract effective March 1, 2018. Seconded by Mr. Skellenger.

Ms. Fantasia explained how the hire will not impact the taxes.

Ms. Fantasia offered additional clarification on the impact to the budget by the new hire, the different shifts that are utilized and excessive overtime issues within the police department. After reviewing the line items in the police budget the new hire along with other adjustments has helped to keep the budget on track.

Mayor Giordano commented at this time we will go back to the regular agenda.

Mayor Giordano requested Ken Nelson of Nelson Consulting Group to explain the redevelopment plan associated with the ordinance.

Mr. Nelson explained the revision to the redevelopment plan dated October 6, 2017. A redevelopment plan gives much more flexibility than a zoning ordinance. Within the plan is where the standards for the redevelopment area are established, including building design standards which aren't normally allowed in zoning ordinances. Also included is a site plan for the property showing layouts for the building and parking areas, as well as the affordable housing obligations. If there are any deviations to the site plan or other standards by the developer they would have to come back to the Council for a re-approval of the redevelopment plan. The hope is that the redevelopment plan and the possibility of a tax abatement will be the catalyst of the development of this property that has been vacant for well over a decade.
