MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ APRIL 23, 2019

<u>Mayor Giordano</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Limon, Mr. Skellenger, Mr. Snyder, Mr. Soules, Mr. Zydon and Mayor Giordano.

Absent: Mr. Postas

Mayor Giordano led the assembly in the flag salute.

Mayor Giordano stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on January 4, 2019, and posted on the Borough website, which adequate notice has been certified by the Clerk."

PRESENTATIONS

Cheryl Krouse, EDC Chair, Patti Carnes, EDC Vice Chair, stepped forward. Ms. Krouse commented they are here this evening to present the April "Business of the Month". As you are aware one of the criteria is they are to give back to the community, tonight's business of the month does just that, donating 10% of their profits back to local organizations. Ms. Krouse announced Mama Cee's is April "Business of the Month". Ms. Krouse invited their manager, TJ to accept the award.

COMMITTEE REPORTS

Mr. Limon commented the auditor was present at last week's Recreation Committee meeting who explained the procedures, policies and how the handling of money should be followed as a Recreation Committee. The Spring Fling is May 11, 2019, at 12 noon at the Franklin Fire House and the Senior of the Year will be announced. Other items discussed were financial responsibilities of events and field maintenance. Mr. Limon stated recreation is soliciting members, if anyone is interested or knows someone who is interested to please contact them, support is needed. The net for behind the back of the baseball field has been purchased and will need to be installed prior to the opening of the baseball and softball season that is April 27, 2019.

Mr. Snyder commented numerous nets have been purchased over the years, maybe the Borough should be looking at a better grade net.

A discussion on nets continued.

Mr. Snyder commented a buildings & grounds meeting will be needed soon to discuss mulch and possible expansion for the new ADA playground equipment.

Mayor Giordano commented placing the exercise station equipment gifted to us by the YMCA also needs to be discussed.

Mr. Soules commented at the Public Works meeting last week discussions took place on the camering of the sewer lines that will take place through the summer, sewer line repairs behind the Lukoil will be done when the weather improves, some of the storm drains were inspected on the roads that are going to be paved and rehabbing the wells in the future.

Mayor Giordano questioned if discussions took place on coordinating road paving on Washington Ave. and School Plaza with the school.

Mr. Snyder commented on where the potential gas line will be coming from that Franklin School is getting, it could impact the paving of the road.

Mr. Zydon recommended contacting Mr. Knutelsky to get more information on the road paving and how the gas line might affect the paving schedule.

Mr. Skellenger commented at the Recreation Committee meeting Tom Ferry, Auditor recommended the Council approve the Recreation Committee to solicit donations on behalf of the Borouh.

Mr. Skellenger made a motion to approve giving authorization to the various committees of Franklin Borough to solicit and accept donations to the Borough into the finance department to be directed to the proper committee from this day forward. Seconded by Mr. Limon.

Mr. Zydon commented there was a joint EDC meeting with Hardyston Township on April 11, 2019, at 7:00PM. Items discussed were the infrastructure of the roads, water and sewer and improvements or lack of improvements in the area. Also, both Hardyston and Franklin will get together with a real estate developer to look at our towns to find strengths and weaknesses. The meeting brought awareness to the joint EDC between Franklin and Hardyston and their future municipal cooperation. Mr. Zydon also commented there was an Ordinance Committee meeting on April 16, 2019, with Mr. Ursin, reviewing various ordinances. Mr. Ursin will provide the committee with sample updated and revised ordinances and lastly, we reviewed the code book to possibly move some items around and remove outdated and obsolete ordinances from it.

Mr. Ursin had nothing to report.

Mayor Giordano commented we will be having a short executive session right after the first public session of the meeting for police litigation matters and then a second executive session at the conclusion of the regular agenda for litigation. Mayor Giordano also commented on the Zoning Officer position and looking into a shared service with Hardyston Township. Mayor Giordano requested Mr. Zydon to contact Hardyston to see if they'd be interested in discussing a shared service for zoning officer services. Mayor Giordano informed the public April 27, 2019, is the Girl Scout town wide garage sale day and encouraged everyone to go out and drive safely.

Mr. Limon made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Skellenger. All were in favor.

Dick Durina, 23 Lozaw Road, Franklin stepped forward. Mr. Durina questioned if the budget will be approved this evening. Mr. Durina commented on a newspaper article he read about various grants that Hopatcong has received. Mr. Durina thanked Mr. Soules for attending the opening of the new Rock Store on Main Street, who was the only representative of the Council to attend.

Mr. Zydon commented some of the Council members weren't able to attend because of work responsibilities.

Cheryl Krouse, 160 Munsonhurst Road, Franklin stepped forward. Ms. Krouse thanked Mr. Soules for attending the (The Rock Store) ribbon cutting and in the future when new businesses are opening to contact the EDC and they will help to coordinate opening events to accommodate schedules of others.

Shane Hrbek, 343 Rutherford Avenue, Franklin stepped forward. Mr. Hrbek requested a status update on the RFQ's that were sent out for the pond services and if there is a plan "B" if no responses are received.

Mr. Snyder commented on contacting the previous lifeguards that were used last year.

Joanne Tatka, 151 Maple Road, Franklin stepped forward. Ms. Tatka questioned if Joe Drossel, Zoning Officer has resigned and is he working for Hamburg Borough.

Ms. Tatka commented on the amendment of \$50.000 added to the 2019 CY introduced budget, the location of the WVFAS coin toss and the salary range ordinance that are on the agenda this evening. Ms. Tatka also commented on the percentages for employee raises.

Dawne Rowe, 140 Munsonhurst Road, Franklin stepped forward. Ms. Rowe commented on where the extra \$50,000 was coming from.

There being no one else present who wished to address the Governing Body, Mr. Zydon made a motion to close the meeting to the public, seconded by Mr. Limon. All were in favor.

Monica Miebach, CFO explained resolution #2019-38, it is to amend the temporary operating budget and covers only the month of April.

Mayor Giordano commented the 3-month temporary budget previously passed will expire if we don't adopt this (resolution 2019-38).

Public Hearing on the 2019 Budget

Mr. Skellenger made a motion to open to the public on the 2019CY Municipal Budget. Seconded by Mr. Soules. All were in favor.

Dick Durina, 23 Lozaw Road, Franklin stepped forward. Mr. Durina commented if an introduction to the budget will take place.

Mayor Giordano invited Monica Miebach to present a brief summary on the 2019CY Municipal Budget.

Monica Miebach, CFO stepped forward. Ms. Miebach commented Tom Ferry, Auditor is not able to be here this evening, he has prepared a 2019 budget summary pamphlet, copies are in the back of the room and were provided to the Mayor and Council. Ms. Miebach explained the pamphlet page by page. The first page is the net valuation table; it is the assessed value of all properties in the Borough which increased from 2018. The budget bottom line increased by \$246,000. Next there is an analysis of our (the Borough) revenues; this how the state budget is formulated. Ms. Miebach also explained budget appropriations, collection rates to calculate for the reserve for uncollected taxes and levy and tax rate. Our tax rate went up approximately a half a penny per 100 of assessed value. The increase in tax for an average home is \$8.43 for the entire year for the Municipal portion, the County, local

and regional schools are estimates because they are still working on their budgets. The water and sewer budget increased 3.9% partially due to additional fees charged from SCMUA because of excess water flows through the water system. Ms. Miebach stated we haven't had a tax increase since 2015.

Mayor Giordano stated the meeting is still open to the public for any questions.

Dick Durina, 23 Lozaw Road, Franklin stepped forward. Mr. Durina commented on his 5 concerns (of the budget); increased spending, \$600,000 from surplus, cutting capital improvements, increasing the debt and salary and wages.

Ms. Miebach commented the debt increase came from the purchase of the new fire truck. Ms. Miebach explained the fund balance, you try not to use more than what has been put in, our dollar figure has stayed level. Ms. Miebach also explained reserves in the capital water and sewer budget and the current fund budget as it relates to capital improvements.

Mr. Durina also commented on the importance of improving the Borough's water infrastructure, and repairs to the roads.

Mr. Limon commented on results that happened in the past when deciding not to purchase a police vehicle.

Mr. Zydon commented on a new vehicle maintenance program that has been implemented.

Mr. Durina commented on the percentage of wages and salaries in the budget.

A discussion took place on wages and salaries of the Borough.

Mr. Snyder made a motion to close the meeting to the public. Seconded by Mr. Zydon. All were in favor.

Resolution #2019-39 Amendment to the 2019 Introduced Budget

Mr. Limon made a motion to accept an amendment to the introduced budget. The amendment will increase the total budget revenues and appropriations by \$50,000. Seconded by Mr. Skellenger.

Monica Miebach commented this budget amendment is needed because certain bills came to her after the time of the introduced budget on March 26, 2019.

Monica Miebach requested Mayor Giordano approve a special meeting for a public hearing on the budget amendment and then the final adoption of the amended final 2019 budget. Waiting until the next regular meeting on May 14, 2019 will cause problems for purchases for projects needing to be done within the DPW.

Mr. Skellenger made a motion to schedule a special meeting on Monday, April 29, 2019 at 7:00PM. Seconded by Mr. Zydon.
