MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ JANUARY 28, 2020

<u>Mayor Sowden</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mr. Limon, Mr. Postas, Mr. Snyder, Mr. Zydon and Mayor Sowden.

Mayor Sowden led the assembly in the flag salute.

COMMITTEE REPORTS

Mr. Limon reported there was a Public Utilities Committee meeting last week that the chairman will report on. There will be a Personnel Committee meeting this week.

Mr. Postas reported at the Public Utilities Committee meeting we went over plans for projects for this year. Brian (VanDenBroek) updated the committee on the Munsonhurst Road wells. Well "B" had a pump replaced, Well "A" which is the deeper of the 2 wells, will most likely only need nothing more than air lifting and cleaning out potential sediment in order to get the wells back to their original flow rates.

Mr. Snyder reported the Personnel Committee will be meeting tomorrow night to go over several items and will report back on that at the next meeting.

Mr. Zydon reported at the Ordinance Committee meeting, we primarily updated Mr. Formica on what has been worked on. Last year we were working with the Planning Board for revisions to commercial items, this year we will be reviewing ordinances that could cause possible restrictions to residential improvements.

Mr. Formica reported the Finance Committee met last night, Mr. Rheinhardt was in attendance and we have been in contact with some of the different department heads in preparation of the budget.

Mr. Zydon reminded the Council the department head evaluation sheets are due at the end of the month to the Clerk. Mr. Zydon explained the process for the evaluations.

Mr. Ursin had nothing to report.

Ms. Tremont, Clerk had nothing to report.

Mayor Sowden reported on the EDC reorganization meeting that took place on January 9, 2020. The new chairperson is Patti Carnes. Mayor Sowden commented he and Mr. Zydon have been discussing some ideas that they will be bringing to the EDC along with revamping some old commissions. Debra Card, Zoning Officer was at the meeting and provided information on businesses and other things happening in Franklin that the EDC wasn't aware of. It was a very informative meeting for all.
