#### Discussion on Property Maintenance Lease Agreement

At this time there was a discussion for the property maintenance lease agreement for 172 Maple Road, Block 1901, Lot 30.

Mr. Zydon asked if the building on that property will be knocked down.

Mayor Sowden commented there are no plans to demolish the building. We [the Borough] are working on plans to auction off this property in the coming months. Also, this will relieve the DPW from needing to mow the lawn weekly, saving them many hours in maintenance.

Administrator McHose commented the demolition costs are high.

Mr. Formica explained building restrictions on the property that include wetlands. If the building is removed there may not be an opportunity to build a new one. The Borough would then be auctioning off an empty lot limiting the number of potential buyers.

Mr. Snyder commented on insurance liability responsibilities of the Borough if the building remains.

Mayor Sowden commented as a safety measure we will be boarding up the building.

Mr. Skellenger made a motion to approve the property maintenance lease agreement with Terry Babcock. Seconded by Mr. Snyder.

# American Legion Post 132 Request to Waive Raffle License Fees

# **OPEN PUBLIC SESSION II**

Mr. Postas made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Skellenger. All were in favor.

Joanne Tatka, 151 Maple Road, Franklin was granted permission to join the meeting after raising her hand. Ms. Tatka questioned what the personnel agreement was about.

Mr. Ursin commented the personnel agreement contents remain private until the Council approves the agreement, now that they voted on it, it's now a public document. The agreement involves police officer Jeffrey Snyder, a suspension, a return to the force and back pay and can now be obtained through an OPRA request submitted to the Clerk for more detailed information.

There being no one else present who wished to address the Governing Body, Mr. Zydon made a motion to close the meeting to the public, seconded by Mr. Skellenger. All were in favor.

## **MISCELLANEOUS COMMENTS**

Mr. Zydon commented he was very pleased about the letter from Tammie Horsfield [Sussex County Chamber of Commerce President] to Governor Murphy regarding restarting our economy. Mr. Zydon encouraged municipalities to work together to push that message to the Governor. Mr. Zydon also commented we as elected officials need to get involved to help get people back to work.

Mayor Sowden commented some councilmen have sent their own letters and suggested drafting a similar letter from the Mayor and Council as a whole to Trenton.

Mr. Limon commented on the stay in place order in effect to June 6 and the reopening our Municipal park. Mr. Limon asked if we are looking into ways to save the Borough money. Is it possible to look into reducing our police force at night since it is slow and nothing is going on during that time or maybe we should look into reducing other department staff hours, it's important to look at all options. Mr. Limon voiced his concerns on how the Borough will be affected financially when this is all over.

Mayor Sowden commented the park has never been closed through this, we just ask that everyone maintain social distancing. He has kept in contact with Debbie, Alison, Department Heads and other officials to aide in making decisions as well as sending as much information received through emails to the Council.

Mr. Postas explained employee schedules, salaries and contract obligations to those various departments that have them. Mr. Postas commented he is concerned about our small businesses and how mental and financial problems are going to be much worse than the virus itself if we can't get back to work.

Administrator McHose thanked Police Chief Cugliari and the Police Department for doing a great job during this difficult situation that they are in. She is fully confident that the Chief is making all staffing decisions as is expected as part of his job. The public also has shown their appreciation by bringing cards, signs and food for the officers. The DPW is working full time doing their normal duties as well as catching up on other projects that need attention.

Mayor Sowden commented the Mayor and Council does not Govern the day to day operations of the Police Department. Mayor Sowden stated the hours and patrols have changed because the manpower is not the same.

Mr. Limon commented that was all he was asking and thanked Mayor Sowden.

### **ADJOURNMENT**

There being no further items for discussion by the Mayor and Council, Mr. Skellenger made a motion to adjourn the meeting at 7:50p.m., seconded by Mr. Limon.
