Mr. Ursin explained this is an assessment for CenturyLink equipment which is utility infrastructure, it is not for real property of any buildings. The CenturyLink property [utility infrastructure] was valued by the County Tax Board last year as exempt that went into effect at the end of the year and was effective for January 1, 2020. CenturyLink paid their taxes in advance that caused an overpayment. Refunding this money doesn't affect the tax base or money paid to the County or Schools.

Mayor Sowden commented patching the potholes could be providing some relief until they're paved. Paving is still on schedule for September/October and will contact Mr. Knutelsky on a more specific starting date.

Mr. Zydon commented on why he voted no on resolution 2020-66. He has concerns with the bid being so low and the possible need for additional funds for unexpected expenses that may come up during the project.
