Mayor Sowden reported on November 30, 2020 our Municipal Court office was inspected by the Municipal Division Manager. The Borough received a letter stating the Municipal Court is well-organized and efficiently managed, commending Lori Spirito, Court Administrator for her cross-training effort of Lauren Mitchener, Deputy. Mayor Sowden commented our court system is working well and thanked Lori Spirito and Lauren Mitchener for handling everything great especially under these extreme times. Mayor Sowden also commented we are at beginning steps to certification for the eligibility of a Historic District. It is amazing that Franklin Borough has the capability of the period of significance that dates back from 1765-1954. Under the NJ National Register criteria, we fit the A, B, C and D of historic significance. Dr. Bill Truhan along with others in his committees such as Phil Crabb, Judy Williams has been working on this for quite a few years. There are some additional procedural items that will need to be done and once those are completed, we will be submitting that to the Planning Board and Council so everyone is aware of what we are trying to do. This could be a boom for Franklin Borough in a lot of different ways. Mayor Sowden stated he is working with the County on the Rails to Trails program and also helping the NJDEP on their purchase of the final piece of rail line located behind the Immaculate Church to help them develop the plan.

Mr. Formica asked how this [Historic Designation] will impact building and construction in town.

Mayor Sowden commented we will be working with the State and the Planning Board so it doesn't affect new building or construction. We just want to preserve the historic buildings we have.

Mr. Snyder questioned if Franklin Borough had already received Historic Designation previously.

Mayor Sowden commented we never got that far. Mayor Sowden also commented he is very excited and happy. We have a very good dedicated group of people working with Bill Truhan to continue to move forward with this all. The Planning Board will be key to where we go with everything.
