Mayor's Statement

Mayor Sowden wished everyone a very happy and healthy new year and thanked everyone for joining us on our 108th reorganization meeting of the Borough of Franklin. Mayor Sowden welcomed back Councilmen Joe Limon and John Postas to another 3-year term and is looking forward to working with you and the rest of the Council this year. Mayor Sowden commented on the past year and the challenges of working through this historic pandemic. We, the Franklin Borough residents have always found a way to survive. Franklin Borough will change its future by leveraging our past and invites everyone to join us on the journey as Franklin Borough moves forward with projects that will once again define this town. Mayor Sowden explained his plans for the year starting with formally establishing the Historical Commission and the receipt of our certificate of eligibility from the State of New Jersey Historic Preservation Office. We will use this to benefit our history. We will not allow anymore demolition of buildings from our past, but rather to enhance the education of our children. We will preserve the Edison School House/Hungarian Church. This will become a show case to remember the Neighborhood House. We will utilize grants and other sources of income for the work that will be needed to be done. Mayor Sowden stated this will become "ground zero" for the revitalization of Main Street, announcing "the talking is over we will roll up our sleeves and get to work". Next, Mayor Sowden spoke of focusing on the upper Zinc Mine Property along with the Franklin Theater that will become the main anchor of the Main Street revitalization. Other items we want to focus on is the pond, athletic fields, playgrounds and walking paths so more people can enjoy what we have to offer. Mayor Sowden complimented the office staff in Borough Hall, DPW, Police Department, Fire Department and First Aid Squad, along with the many Board members that help run our town. Mayor Sowden concluded by stating "taking back our heritage and preserving our future, ladies and gentlemen, let's get started".

Council Comments

Mayor Sowden invited each member of the Council to offer remarks concerning the 2021 Council's goals and priorities.

Mr. Limon commented on the items the Mayor spoke of regarding Main Street and an article that was in the newspaper about preserving the history of Main Street, which he supports greatly. Mr. Limon also commented he is worried about taxes and the difficult year we've had. He reminded everyone that we are only a portion of what makes up the tax rate and we must keep our portion down. He looks forward to working with everyone this year.

Mr. Postas thanked the Mayor and Council for this past year. Mr. Postas commented we held the line on our taxes. We are still in the middle of a pandemic but the town progressed through it all. With the Mayor's vision for the future along with the rest of the Council I see nothing but a bright future for this

town. We want to invest back in the town to keep the population we have here and so they don't want to go anywhere else. Mr. Postas offered his condolences to Councilman Zydon and his wife, Sarah on the loss of her grandfather.

Mr. Snyder wished everyone a happy new year and congratulated Councilmen Limon and Postas on their re-election for another 3-year term. Mr. Snyder thanked all the volunteers that have helped keep everyone safe and to all the employees of Franklin. Mr. Snyder also thanked the Council for the confidence shown by electing him as Council President. It has been a struggle to keep taxes down but we will find a way to do it. We must never give up.

Mr. Formica wished everyone a happy new year. Last year was my first on the Council, it was certainly a crash course in everything from the pandemic, budget, rules, etc. and this year he wants to be more involved. We have so much potential in this town, many avenues to open up and as was said we must stop talking about it and take action. It's time to move forward and get the ball rolling.

Mr. Skellenger wished everyone a happy and healthy new year and congratulated Councilmen Limon and Postas on their re-election. Mr. Skellenger thanked all the volunteers who have protected us through this pandemic. Mr. Skellenger commented he looks forward to working with everyone on the Council this year.

Mr. Zydon wished everyone a happy new year and thanked Mr. Postas for his condolences on his wife's grandfather who was 96 years old, a veteran of WWII and worked for Picatinny Police force. Mr. Zydon commented Franklin has been here a long time and we will not let it die. Mr. Zydon also commented he agrees the talk is over and we must get moving. He is glad he is still on EDC; they have been working actively in getting businesses interested in our town. Mr. Zydon stated he is glad to work with everyone; let's make 2021 a stellar year and leave 2020 behind.
