## <u>Discussion of ordinance amending Chapter 119 of the Borough Code – "Fees"</u>

At this time there was a discussion with possible action taken of an ordinance entitled "AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY AMENDING CHAPTER 119 OF THE BOROUGH CODE ENTITLED "FEES"."

Mr. Postas commented that this is an amendment to this ordinance where we are increasing the price of the parking fees for the lot on the corner of Main Street and Parker.

Mr. Formica commented that he feels at this time going from zero to \$300 in light of the pandemic and the hardships that some of the residents are going through is kind of extreme and it is not a good time to implement this. It is free parking during the day and this change would only impact the people who park overnight since there is no overnight parking.

Mr. Postas commented that it is not a free parking fee now, it is a \$75 fee. The new fees would not take effect until June because that is when everyone will have to renew. We have people parking there and we cannot keep up with the upkeep of the lot.

Mr. Zydon commented that we changed the ordinance on Main Street to 2 hour parking all day. Therefore, people will have to use the parking lot and the parking lot will need to be improved.

Mr. Snyder commented that we need to improve the parking lot and the only way to do that is to change the fees for parking.

After a lengthy discussion, Mr. Zydon made a motion to table this discussion. Seconded by Mr. Skellenger. All were in favor.
