BOROUGH OF FRANKLIN COUNTY OF SUSSEX ORDINANCE #7-2013

AN ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION OF \$25,000 FOR THE PREPARATION AND EXECUTION OF A COMPLETE PROGRAM OF REASSESSMENT OF REAL PROPERTY IN THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY FOR THE USE OF THE LOCAL ASSESSOR OF THE BOROUGH

WHEREAS, the Sussex County Board of Taxation has ordered the Borough of Franklin, New Jersey to implement a reassessment of real property in the Borough of Franklin; and

WHEREAS, the Local Budget Law of New Jersey and in particular N.J.S.A. 40A:4-53, provides that a municipality may adopt an ordinance authorizing a special emergency appropriation for, among other things, the preparation and execution of a complete program of reassessment of real property for the use of the local assessor when such is ordered by the County Board of Taxation.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Franklin in the County of Sussex, State of New Jersey as follows:

Section 1. A special emergency appropriation in the amount of \$25,000 Is hereby authorized and made for the purpose of the preparation and execution of a complete program of reassessment of real property in the Borough of Franklin, New Jersey for the use of the local assessor of the Borough.

Section 2. The Borough is hereby authorized to finance such appropriation from surplus funds available or by issuing special emergency notes from time to time in accordance with the provision of N.J.S.A. 40A:4-55, all as shall be determined by and pursuant to a resolution or resolutions of the Borough to be hereafter adopted.

Section 3. In accordance with the requirements of N.J.S.A. 40A:4-53, a copy of this ordinance as adopted shall be filed with the Director of Local Government Services in the Department of Community Affairs of the State of New Jersey.

Section 4. This ordinance shall take effect after publication after final adoption as provided by law.
