# AN ORDINANCE UPDATING CHAPTER 119 REGARDING TOWING FEES IN THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX AND STATE OF NEW JERSEY

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Franklin, Sussex County, New Jersey, as follows:

#### **SECTION I**

The Code of the Borough of Franklin is hereby modified to replace the fee references to Chapter 248 located in Chapter 119 (All other provisions of Chapter 119 remain unchanged):

§ 248-4

Inclusion on list of qualified wreckers

\$400 per year

§ 248-15

Towing services provided 24 hours per day, 7 days per week, Monday through Friday:

First towed mile or less

\$125

Each additional mile

\$4

Daily storage fee (Cars and Trucks/Motorcycles) \$50/\$35

Towing Company Administrative fee

\$30

Covers/tarps \$50

Yard Fee

\$30

Clean up fee \$50-150

Recovery/Winching Fees

\$75-250

Wait time

\$60 per hour

§ 248-18

Administrative fee

[delete \$20 per vehicle fee]

**SECTION II** All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

#### **SECTION III**

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

#### **SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.
