## BOROUGH OF FRANKLIN ORDINANCE NO. 04-2016

ORDINANCE AUTHORIZING LEASE AGREEMENT BETWEEN THE BOROUGH OF FRANKLIN AND NORTHWEST NEW JERSEY COMMUNITY ACTION PROGRAM, INC. FOR A PORTION OF MUNICIPALLY OWNED PROPERTY LOCATED AT GEORGE LABANCE LANE

WHEREAS, the Borough of Franklin ("Borough") owns public property known as the Franklin Senior Center located at George LaBance Lane, Franklin, New Jersey described further as Block 2401, Lot 6.01 on the Official Tax Map of the Borough of Franklin ("Property"); and

WHEREAS, there is one vacant office on the ground floor of said Property; and

WHEREAS, Northwest New Jersey Community Action Program, Inc. ("NORWESCAP") applied to the Borough seeking to rent space for nominal consideration; and

WHEREAS, the governing body of the Borough of Franklin believes that NORWESCAP serves an important public purpose and desires to provide them with some assistance; and

WHEREAS, the leased space will be used by NORWESCAP as its base of operations for implementing community assistance programs within the Borough and surrounding area; and

**WHEREAS**, the Local Lands and Buildings Law, <u>N.J.S.A.</u> 40A:12-14(c) allows a municipality to lease property to a nonprofit corporation for a public purpose.

NOW, THEREFORE, BE IT ORDAINED that the governing body of the Borough of Franklin hereby approves of a lease with NORWESCAP for one office on the ground floor of the Franklin Senior Center for a term of three (3) years beginning on

January 1, 2016 at the initial rate of \$197.71 per month with a rent increase of 4% per annum provided, as required by N.J.S.A. 40A:12-14(c), that NORWESCAP shall submit an annual report to the Borough Administrator, who is the officer designated by the governing body to supervise the lease, describing (i) the use of the property which is the subject of the lease, (ii) activities performed in furtherance of the public purpose for which the lease was granted, (iii) the approximate value or cost of the activities in furtherance of the public purpose, and (iv) an affirmation of the continued tax-exempt status of the nonprofit corporation or association pursuant to both State and federal law.

NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall take effect upon final adoption and publication pursuant to law.
