## BOROUGH OF FRANKLIN COUNTY OF SUSSEX ORDINANCE # 12-2016 AMBULANCE CAPITAL PURCHASES

AN ORDINANCE APPROPRIATING THE SUM OF \$20,000.00 FROM RESERVE FOR AMBULANCE EQUIPMENT BY THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY.

**BE IT ORDAINED AND ENACTED** by the Mayor and Council of the Borough of Franklin, County of Sussex, New Jersey, as follows:

**SECTION 1:** The sum of Twenty thousand dollars (\$20,000.00) to be utilized out of the Reserve for Ambulance Equipment, is hereby appropriated for the following purpose:

For the purchase of a Power Gurney.

**SECTION 2:** In connection with the amount authorized in Section 1 hereof, the Borough makes the following determination:

- (a) The purpose described in Section 1 hereof is not a Current Expense and is an improvement, which the Borough of Franklin may lawfully make as a Current Capital Improvement.
- (b) The period of usefulness of the purpose described in section 1 hereof is not in the limitations of the said Local Bond Law and according to the aggregate reasonable life thereof is five (5) years.

**SECTION 3:** All ordinances or parts of ordinances, which are inconsistent with the terms of this ordinance, be and the same is hereby-repealed to the extent of their inconsistency.

**SECTION 4:** This ordinance becomes effective immediately upon final passage, approval, and publication as provided by law.
