**RESOLUTION AUTHORIZING AN AMENDMENT TO AN AGREEMENT WITH THE
BOROUGH OF FRANKLIN AND COUNTY OF SUSSEX FOR ENFORCEMENT AGENCY
SERVICES AS SET FORTH IN THE NJ STATE UNIFORM FIRE CODE REGULATION IN
ACCORDANCE WITH THE PROVISION OF N.J.S.A. 40A:65-1 ET SEQ.**

WHEREAS, On October 13, 2015, the Borough of Franklin approved the shared service agreement between the County of Sussex and the Borough of Franklin for Enforcement Agency services through the Sussex County Fire Marshal pursuant to N.J.S.A. 40A:65-1 et seq; and,

WHEREAS, the Sussex County Fire Marshal has been notified by the Department of Community Affairs, New Jersey Division of Fire Safety, of minor changes to the Fee Schedule annexed to the said Share Services Agreement; and,

WHEREAS, the attached amended Shared Services Agreement incorporates the changes to it necessitated by the revision to the Fee Schedule; and,

WHEREAS, all other aspects of the County's October 14, 2015, resolution and annexed agreement remain in full force and effect, and the within resolution and annexed agreement does not replace but supplements the prior one.

NOW, THEREFORE, BE IT RESOLVED, the Borough of Franklin of the County of Sussex, hereby agrees to enter into an amended shared services agreement with the Borough of Chosen Freeholders of the County of Sussex for the purpose of providing the enforcement agency services as more specifically provided for in the said Shared Services Agreement; and,

BE IT FURTHER RESOLVED, by the Governing Body of the Borough of Franklin, the clerk and Mayor are hereby authorized to execute the attached amended Shared Services Agreement between the Borough of Franklin and the County of Sussex, and take any other necessary action in furtherance thereof; and,

BE IT FURTHER RESOLVED, certified copies of this resolution and agreement shall be forwarded to Catherine Williams, Clerk of the Board of Chosen Freeholders of the County of Sussex.
