**RESOLUTION 2016-25 AUTHORIZING SALE OF SURPLUS PROPERTY
OWNED BY THE BOROUGH OF FRANKLIN THROUGH
GOVDEALS.COM PURSUANT TO STATE APPROVED CONTRACT**

WHEREAS, the Borough of Franklin (“Borough”) is the owner of certain surplus property, which is no longer needed for public use; and

2. The sale will be conducted online and the address of the auction site is govdeals.com.


3. The sale is being conducted pursuant to Local Finance Notice 2008-9.


