BOROUGH OF FRANKLIN COUNTY OF SUSSEX Ordinance # 15-2017

AN ORDINANCE AMENDING CHAPTER 259 "PARKING," Code of the Borough of Franklin § 259-5

WHEREAS, the Franklin Borough Mayor and Council finds and declares the promotion of vehicular and pedestrian safety on the Borough's streets and roads is of paramount concern; and

WHEREAS, Franklin Borough desires to amend certain specific parking requirements under the Code of the Borough of Franklin §259-5, as more specifically stated below;

NOW, THEREFORE, BE IT ORDAINED by the Franklin Borough Mayor and Council amends the Borough Code as follows with <u>bolded & underlined text</u> representing new text to be added as part of this amendment, and <u>strikethrough text</u> representing deleted text as follows:

Chapter 259 "Parking"

Section §259-5

E. Parking time limited on certain streets. No person shall park a vehicle for longer than the time limit between the hours listed on any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

Name of Street	Sides	Time Limit (hours)	Location
Main Street	North	1/2	From the intersection of Main Street and Junction Street, 220 feet in an easterly direction
Main Street	North	2	From a point beginning 220 feet in an easterly direction from the intersection of Main Street and Junction Street, extending to Hudson Street
Main Street	North	2	From a point beginning 235 feet in an easterly direction from the intersection of Main Street and Wyker Road, extending to Junction Street
<u>Main</u> Street	<u>North</u>	<u>2</u>	From the intersection of Main Street and Junction Street extending in an easterly direction to the intersection of Main Street and Parker Street

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this ordinance are hereby repealed in their entirety; and,

BE IT FURTHER ORDAINED, this ordinance shall take effect after its final passage and publication as required by law.
