# AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX AND STATE OF NEW JERSEY CANCELING THE SAFE ROUTES TO SCHOOL GRANT

WHEREAS, the Borough of Franklin applied for a Safe Routes to School Program from the NJ Department of Transportation;

**WHEREAS**, the grant was to construct sidewalk replacements along the school route for Franklin Borough Elementary School and Immaculate Conception Regional School;

**WHEREAS,** by letter dated March 3, 2015, the Borough of Franklin received a \$330,000 grant in aid financing for the project;

**WHEREAS**, by Ordinance 15-2016, the Borough Council appropriated the funds of \$315,000 expected to be received from the Safe Routes to School as a grant in aid financing in Section 3(d);

WHEREAS, Immaculate Conception Regional School has been consolidated and no longer functions as an elementary school;

WHEREAS, the cost estimates for the project have increased dramatically;

WHEREAS, the Administrator and the CFO have recommended canceling the project and rejecting the unfunded grant money of \$300,000;

NOW THEREFORE IT BE ORDAINED by the Governing Body of the Borough of Franklin that the appropriation for the grant for the Safe Routes to School grant money set forth Ordinance 15-2016, Section 3(d), is hereby canceled and that portion of the Ordinance is vacated. All other portions of the Ordinance remain in full force and effects
