AN ORDINANCE AMENDING CHAPTER 60 REGARDING THE POLICE DEPARTMENT IN THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX AND STATE OF NEW JERSEY

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Franklin, Sussex County, New Jersey, as follows:

SECTION I The Code of the Borough of Franklin is hereby amended to replace Section 60-4 as follows:

§ 60-4 Organization.

There is hereby created in and for the Borough of Franklin a Police Department which shall consist of a Chief of Police and the positions of Captain, Lieutenant, Sergeant and Patrolmen in numbers approved by the Mayor and Council. The Department may also consist of other support employees as deemed necessary by the Mayor and Council.

SECTION II All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV This Ordinance shall take effect immediately upon final publication as provided by law.
