ORDINANCE No. 15-2018

AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY AMENDING SECTION 259-5 REGARDING PARKING

BE IT ORDAINED by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that Chapter 259 of the Franklin Borough Code is amended as follows:

SECTION I

Subsection 259-5E is replaced as follows:

E. Parking time limited on certain streets. No person shall park a vehicle for longer than the time limit between the hours listed on any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

Name of		Time Limit	
Street	Sides	(hours)	Location
Main Street	North	2	From the intersection of Main Street and Junction Street, 220 feet in an easterly direction
Main Street	North	2	From a point beginning 220 feet in an easterly direction from the intersection of Main Street and Junction Street, extending to Hudson Street
Main Street	North	2	From a point beginning 235 feet in an easterly direction from the intersection of Main Street and Wyker Road, extending to Junction Street
Main Street	North	2	From the intersection of Main Street and Junction Street extending in an easterly direction to the intersection of Main Street and Parker Street

SECTION II

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV

This Ordinance shall take effect immediately upon final publication as provided by law.
