RESOLUTION OF THE GOVERNING BODY
OF THE BOROUGH OF FRANKLIN
TO DEDICATE THE ISLAND ON FRANKLIN POND
TO JUDY POSTAS

WHEREAS, Mrs. Judy Postas grew up in Franklin Borough and enjoyed a loving, active childhood with family and friends who spent hours playing sports, walking to the Franklin Pond to swim or ice skate and later in her life, Mrs. Judy Postas shared these same activities with her husband and four children;

WHEREAS, Mrs. Postas attended and graduated from Franklin Elementary and High Schools, and later became a beloved teacher at the Franklin Elementary School, impacting the lives of hundreds of students over her almost thirty year career;

WHEREAS, Mrs. Judy Postas was generous with her time devoting hours to community organizations including the Girl Scouts, the Salvation Army and an organization she helped found called "Grace's Open Door". Judy was an active member of the Franklin Presbyterian Church for many years;

WHEREAS, Mrs. Judy Postas spent countless hours hiking and kayaking in the beautiful forests and lakes of Sussex County, and she continued to enjoy kayaking at the Franklin Pond and other parks in the area, well after being diagnosed with cancer. One of her favorite spots on the Franklin Pond, was the island with the flag pole and can be seen from CR 631 or Franklin Avenue;

WHEREAS, the Borough Council recognizes Mrs. Judy Postas as a distinguished citizen of Franklin Borough who had a strong affection for Franklin Borough and its residents and she had a special connection with the island of Franklin Pond;

NOW THEREFORE BE IT RESOLVED by the Franklin Borough Council that the Mayor and Council hereby dedicates the island on Franklin Pond to the memory of Judy Postas, naming the island "Judy's Island" and directs the Borough Administrator to secure estimates for an appropriate plaque to be placed on the island memorializing this naming and dedication.
