

**RESOLUTION #2020-21
OF THE GOVERNING BODY
OF THE BOROUGH OF FRANKLIN
COUNTY OF SUSSEX**

AUTHORIZING THE APPOINTMENT OF A BUSINESS ADMINISTRATOR/CHIEF FINANCIAL OFFICER/QUALIFIED PURCHASING AGENT AND FURTHER AUTHORIZING THE EXECUTION OF AN EMPLOYMENT CONTRACT

WHEREAS, N.J.S.A. 40A:9-140.10 requires every municipality in the State of New Jersey to have a Chief Financial Officer to be appointed by the governing body; and

WHEREAS, Chapter 5, Article IV of the Borough of Franklin Code provides for the position of Borough Administrator and the employment of the Borough Administrator is hereby authorized under the authority of N.J.S.A. 40A:9-136 et seq.

WHEREAS, the Borough of Franklin requires the services of a Chief Financial Officer and Qualified Purchasing Agent due to vacancies in the positions; and

WHEREAS, the Town Council and Mayor anticipate a vacancy in the position of Business Administrator as a result of a retirement; and

WHEREAS, the Personnel Committee has conducted an extensive search to fill the vacancies in the positions of Chief Financial Officer and Qualified Purchasing Agent; and

WHEREAS, the Personnel Committee recommends the appointment of an experienced Business Administrator who is a Certified Municipal Finance Officer and Qualified Purchasing Agent who wishes to serve in the positions of Business Administrator, Chief Financial Officer and Qualified Purchasing Agent; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Franklin, County of Sussex, State of New Jersey that the Mayor, with the advice and consent of the Borough Council, does hereby appoint a Business Administrator/Chief Financial Officer/Qualified Purchasing Agent according to the terms of the employment contract which the Mayor is authorized to execute and the Borough Clerk to attest to upon the adoption of this resolution.
