PERSON TO PERSON - PLACE TO PLACE TRANSFER**

WHEREAS, an application has been filed for a person-to-person, place-to-place transfer of Plenary Retail Consumption License 1906-33-008-009, heretofore issued to Stone Hill Recreation SPE, LLC for the premises located at Route 23 North, Franklin, NJ 07416, and for the purpose of expanding the premises under license wherein the sale, service and storage of alcoholic beverages are authorized; and

WHEREAS, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

WHEREAS, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

WHEREAS, the applicant has disclosed and the issuing authority reviewed the source of all funds used in the purchase of the license and the licensed business and all additional financing obtained in connection with the licensed business;

NOW, THEREFORE, BE IT RESOLVED that the Borough of Franklin Governing Body does hereby approve, effective November 10, 2020, the Person-to-Person and Place-to-Place, Plenary Retail Consumption License issued to Stone Hill Recreation Corp. and the expansion of the aforesaid premises located at Route 23 North, Franklin, NJ 07416, with a mailing address of 3621 Route 94, Hamburg, NJ 07419, to place under license the area delineated in the application form and the sketch of the licensed premises attached thereto, and does hereby direct the Municipal Clerk to endorse the license certificate to the new ownership as follows: "This license, subject to all its terms and conditions, is hereby transferred to Stone Hill Recreation SPE, LLC, effective November 10, 2020.
