- a. Adaptive reuse of Zincmine Historic Buildings.
 - b. Redevelopment Plan for 120 NJSH Route 23, Block 1601, Lot 5

Ms. Caldwell provided the Governing Body with a handout showing examples of adaptive reuse of buildings in various other areas that could potentially be used at the Zincmine site. Ms. Caldwell asked if the Council would be acceptable to retaining the buildings on the Zincemine site for adaptive reuse.

Mr. Ursin commented that there is potential to preserve the change house as part of the redevelopment plan, you could put in the redevelopment plan an encouragement to preserve the change house. If the Council does not want the change house preserved as part of the redevelopment project than now is the time to tell the planner. The planner needs that information to move forward with the redevelopment plan.

Mr. Postas asked if the developer would be willing to put money up to reuse the change house.

Ms. Caldwell explained the developer's interests.

Mr. Ursin explained the process of the council for this property and stated that the council should decide how they want the property to be developed.

Mayor Sowden expressed his vision for the property.

The consensus of the majority of the Council is to direct the Planner to amend the Redevelopment Plan without preserving the three buildings.

Ms. Caldwell commented that there is a draft redevelopment plan for 120 NJSH 23 (old super Wal-Mart site). There is a redeveloper who is working in conjunction with Ryan Homes and their goal is to build town house development on this site (up to 160 units).

The next step would be to introduce an ordinance and that should be ready to go shortly.

The zinc company did a lot of good for this town. Erin Kidd wrote a thesis about the zinc mine property and her vision for the property.

The adoption of this Ordinance shall not operate to either increase or decrease the present pay of any officer or employee of the Borough of Franklin, and the salaries or compensation under the existing Ordinance shall remain in effect until any additional increments are approved by the Borough Council under this Ordinance. Specific salaries or wages established by the Borough Council may be made retroactive to January 1st of the year in which the resolution is adopted, at the Council's discretion.

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Franklin in the County of Sussex finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council of the Borough of Franklin hereby determines that a 3.5% increase in the budget for said year, amounting to \$64,753 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Mayor and Council of the Borough of Franklin hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Franklin, in the County of Sussex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Borough of Franklin shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$64,753, and that the CY 2024 municipal budget for the Franklin Borough be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT_FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

BE IT FUTHER ORDAINED that this ordinance shall be applied retroactively to be applicable to the introduction and adoption of the 2024 Municipal Budget.
