MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ FEBRUARY 28, 2023

This meeting is being held in person adhering to the CDC guidelines and through a virtual meeting platform called ZOOM. The public who attended through ZOOM has been notified and instructed on how to join the meeting and participate during the public session.

<u>Mayor Sowden</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mrs. Heath, Mr. Limon, Mr. Skellenger, Mr. Snyder and Mayor Sowden.

Mayor Sowden led the assembly in the flag salute.

<u>Mayor Sowden</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on January 6, 2023, and posted on the Borough website, which adequate notice has been certified by the Clerk."

PRESENTATIONS

Historic State (SHPO) Presentation – Secretary of Interior's Standards.

Erin Frederickson and Meghan Baratta from the State Historic Preservation Office discussed different options for the rehabilitation of the Hungarian Church/Edison School House. Ms. Frederickson commented that the siding elements should be retained as much as possible.

Mr. Crabb, Historical Preservation Commission Chairman, asked what materials could be used for the roof of the building and requirements for applying for Grants.

Ms. Frederickson replied synthetic materials can be used according to Franklin's Historical Commission and local ordinances, but recommends reviewing the Secretary of Interior's Standards and you can also seek guidance from the State's Historic Trust. They are always available to help with questions.

Mayor Sowden commented that state funding wouldn't be offered until designated as a Historic Preservation building.

Ms. Frederickson commented applications are open now, You can apply without being listed on the New Jersey Register but then you would need to be in order to be reimbursed.

As far as the finance committee for the budget meeting, after that I did speak to Michelle and she would like to have a workshop meeting with the full council on March 15, 2023. The lifeguard ad has been placed and we have received no applicants as of yet.

Mayor Sowden commented that a decision needs to made as to whether or not we want to move forward with historic preservation and funding or just repair the Hungarian Church/Edison School House.
