# MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ APRIL 12, 2022

This meeting is being held in person adhering to the CDC guidelines and through a virtual meeting platform called ZOOM. The public who attended through ZOOM has been notified and instructed on how to join the meeting and participate during the public session.

<u>Mayor Sowden</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mrs. Heath, Mr. Limon, Mr. Skellenger, Mr. Snyder and Mayor Sowden.

Absent: Mr. Postas

Mayor Sowden led the assembly in the flag salute.

<u>Mayor Sowden</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on January 7, 2022, and posted on the Borough website, which adequate notice has been certified by the Clerk."

#### **PRESENTATIONS**

Mr. Ray Sarinelli Jr., Municipal Auditor commented on the CY2022 Municipal Budget. Mr. Sarinelli commented that the 2022 current budget is in good condition and that the 2022 budget is still being affected by the pandemic. Mr. Sarinelli explained included with the budget is the capital budget, the capital budget is a plan and it includes 14 projects in total. You can choose to do either all or some or even none of the 14 projects that are in there. The capital budget is flexible, unlike the rest of the budget that is set in stone and can't be changed.

Mr. Limon asked if we have heard anything from the schools as far as their rate. Mr. Sarinelli stated that the schools on a fiscal year and the municipality runs on a calendar year.

Mr. Formica questioned the use of the fund balance to help balance the budget and if we [Council] should concentrate on reversing it. Mr. Sarinelli commented the fund balance is strong for the size of your budget. Even though the amount used isn't great, it wouldn't be detrimental to the future.

Mr. Sarinelli commented in looking at the expense side of the budget there isn't much that can be cut. There are some items that can't be controlled such as pension costs and you will need to be aware those are set to increase in the future.

# **COMMITTEE REPORTS**

Mr. Limon had nothing to report.

Mr. Snyder commented that there was an ordinance committee last week with Rachel Heath and Andrew Bernath and we spoke about ordinances regarding hiring procedures, amount of police officers and the jake brake ordinance.

Mr. Formica commented that the planning board is discussing the Housing Plan. The old playground has been removed and the field goal posts have been removed. There was a meeting regarding the wells and information was sent to the council.

Mr. Skellenger commented that a real estate committee meeting will meet to finalize the auction list.

Mrs. Heath commented that on April 1<sup>st</sup>, she, Darlene and Councilman Formica attended the kickoff for the Wallkill Valley Coalition. Mrs. Heath commented that the Recreation Committee is ordering 4 eagle scout plaques and Recreation is planning

to hold the 5k race in the fall. Mrs. Heath commented on replacing the banners for Christmas.

Mrs. Tremont had nothing to report.

Mr. Bernath had nothing to report.

Mr. Ursin had nothing to report.

Mayor Sowden commented that he would like to start working on the Historic Plan and to bring in a professional to talk about it.

### Public Hearing on the 2022 CY Municipal Budget

Ms. Patti Carnes, 289 Rutherford Avenue Franklin stepped forward. Ms. Carnes stated that there is potentially going to be a tax hike from what she heard from discussions earlier and from prior meetings regarding the multi-year assessment plan.

Mr. Ursin explained the reassessment and its effects on individual properties.

Mr. William VanTassel, 28 Nestor Street Franklin was granted permission to join the meeting after raising his hand on ZOOM. Mr. VanTassel asked at what point do we stop raising taxes. Mr. VanTassel commented that the capital improvement costs should be looked at.

Mr. Michael Raperto, 13 South Street Franklin stepped forward. Mr. Raperto asked if any year in the past the municipality has not increased taxes. Mr. Raperto asked what the capital projects are for the year.

Mr. Limon commented that short of letting employees go there is nothing more we can do.

Mr. Snyder commented that consolidation is key.

Mayor Sowden commented that we have to start developing shared services.
