MINUTES OF THE SPECIAL MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ APRIL 20, 2022

This meeting is being held in person adhering to the CDC guidelines and through a virtual meeting platform called ZOOM. The public who attended through ZOOM has been notified and instructed on how to join the meeting and participate during the public session.

<u>Mayor Sowden</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mrs. Heath, Mr. Limon, Mr. Postas, Mr. Skellenger (7:05pm), Mr. Snyder and Mayor Sowden.

Absent: None

Mayor Sowden led the assembly in the flag salute.

<u>Mayor Sowden</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on April 17, 2022, and posted on the Borough website, which adequate notice has been certified by the Clerk."

OPEN PUBLIC SESSION

Mr. Phil Crabb, 31 Jenkins Road, Franklin stepped forward. Mr. Crabb commented on how many times this happened to others. Mr. Crabb commented that the capital budget has no effect on the tax rate. There is a possibility of the Borough losing funding for not adopting the budget as required by the State.

Mr. Stephan Zydon, 346 Rutherford Avenue, stepped forward. Mr. Zydon asked if certain council members are satisfied with the way Main Street looks.

Mr. Snyder commented that he voted the budget down for other reasons.

Mr. Zydon commented that we are going to jeopardize the whole project [Edison School House/Hungarian Church] and he is disappointed.

Mrs. Sarah Zydon, 346 Rutherford Avenue, Franklin stepped forward. Mrs. Zydon asked when is the new budget due and what is the plan.

Mr. Sarinelli commented that the council could potentially re-introduce the budget tonight and adopt at the end of May.

There being no one else present who wished to address the Governing Body, Mr. Snyder made a motion to close the meeting to the public, seconded by Mr. Formica. All were in favor.

Discussion on the 2022CY Budget

Mr. Sarinelli explained the process to possibly introduce the CY2022 budget.

Mr. Bernath explained the one item in question if it's left out at introduction the item can be done at a later time with a capital ordinance.

Mr. Postas commented that he doesn't understand why the money has to be left out of the budget when it doesn't affect the bottom line of the budget.

Mr. Formica commented that he doesn't want to approve money for something without a plan in place.

Mr. Postas made a motion to introduce CY2022 Municipal Budget with the \$2,500 left in the budget. Seconded by Mr. Limon.

Mr. Sarinelli read the tax levy into the record with the \$2,500 included for the school house.

"Be it resolved by the Council members of the Borough of Franklin County of Sussex that budget herein set forth is hereby introduced and shall constitute an appropriation for the purposes stated of the sums therein set forth as appropriations and authorizations of the amount of \$5,086,451.00."
