# MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ JULY 18, 2023

This meeting is being held in person adhering to the CDC guidelines and through a virtual meeting platform called ZOOM. The public who attended through ZOOM has been notified and instructed on how to join the meeting and participate during the public session.

<u>Mayor Sowden</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mr. Limon, Mr. Postas and Mayor Sowden.

After meeting in closed session, the Governing Body returned to their seats at 7:37 p.m. and Mayor Sowden declared the meeting to be reconvened into open public session.

Mrs. Heath joined the meeting via ZOOM at 7:37pm.

# **COMMITTEE REPORTS**

Mr. Limon commented that a public works meeting will be set up this week.

Mr. Postas commented that Brian and the DPW are working on the drainage to get ready for the paving projects this year. The Hemlock Drive bids will be going out soon and there is a meeting next week with the well driller for the new well project.

Mr. Snyder commented that there was a personnel meeting regarding the Police Chief's contract and the same will be voted on tonight.

Mr. Formica commented that the floor at the senior center has been completed and the floor in the elevator has been replaced. DPW dug a trench and put the piping in for the pavilion lighting.

Mrs. Heath commented that the event on July 1st was great.

Mayor Sowden commented that the Governor will be signing the bill tomorrow (July 19, 2023) to make Franklinite the official state mineral of New Jersey. Mayor Sowden spoke to Mr. Vreeland in regards to the cell tower removal.

# **OPEN PUBLIC SESSION**

Sandra Westermann addressed the Governing Body regarding stormwater issues and drainage issues on Maple Road by her property. Ms. Westermann commented that she bought the property in 2017 and there were no issues with flooding until there was pipe worked on in 2021. Ms. Westermann commented that on June 27<sup>th</sup> the DPW installed a berm at the top of the driveway in accordance with the specifications of the engineer. Ms. Westermann stated that the engineer grossly underestimated the volume of water and the berm was breached within 30 minutes of the first rainfall. Ms. Westermann contacted the NJDEP and they agree that stormwater mediation is needed. The wildcat creek water is not running like it used to.

William Westermann addressed the governing body regarding the need for stormwater management on Maple Road.

Joanne Tatka addressed the governing body regarding the water issues on Maple Road. After repaving Maple Road, they did not put a crown in the center of the road. Ms. Tatka asked if the price on the water tower will stay the same.

Dawne Rowe stepped forward. Ms. Rowe asked how the residents will be notified of road paving. Asked why the taxpayer citizens association cannot use the senior center. Asked for a second public session.

There being no one else present or on Zoom who wished to address the Governing Body, Mr. Postas made a motion to close the meeting to the public, seconded by Mr. Snyder. All were in favor.

The tax collection rate was 97% and in general capital there is \$5 million in net debt. There are some older ordinances that can be reviewed and cancelled if they are not being used. There was \$366,000 that was paid down in BANS and the capital improvement fund is maintained at around \$161,000 at year end. The water/sewer operating fund is in a healthy position, it increased \$587,000 in fund balance, most of which or \$455,000 is going to be used to support the 2023 budget. Segregation of duties in the audit comments will probably never change.
