MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FRANKLIN HELD AT THE FRANKLIN MUNICIPAL BUILDING 46 MAIN STREET, FRANKLIN, NJ AUGUST 16, 2022

This meeting is being held in person adhering to the CDC guidelines and through a virtual meeting platform called ZOOM. The public who attended through ZOOM has been notified and instructed on how to join the meeting and participate during the public session.

<u>Council President Formica</u> called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mr. Formica, Mrs. Heath, Mr. Limon, Mr. Skellenger, Mr. Snyder.

Absent: Mr. Postas, Mayor Sowden

Council President Formica led the assembly in the flag salute.

<u>Council President Formica</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on January 7, 2022, and posted on the Borough website, which adequate notice has been certified by the Clerk."

PRESENTATIONS

COMMITTEE REPORTS

Mr. Limon had nothing to report.

Mr. Bernath commented that there was a personnel meeting earlier to discuss the Teamsters Contract and that should be moving forward for the next meeting. The garbage bid is being finalized; we are just waiting on the tonnage reports from Blue Diamond for the previous three years. I have been in contact with the water/sewer engineer on getting the bid specs completed for the water tower repainting and refurbishing. The new hire for DPW has completed the background check and drug screening as soon as the results are received, we will have a start date for him. The grant application was submitted for the fire fighter grant.

Mr. Snyder commented that we are still trying to set up a meeting with the County Engineer in regards to the speed limit on Church Street.

Mr. Formica commented that the roads have been paved and will be striped soon.

Mr. Skellenger had nothing to report.

Mrs. Heath commented that the Recreation meeting had to be canceled because there was no quorum.

Mrs. Tremont commented that she received an email from Congressman Gottheimer's office, they are going to have mobile office hours here at Borough Hall prior to our Mayor and Council meeting on September 13, 2022 from 6pm-7pm. The County Board of Health has contacted our office and they would like to hold a flu/covid vaccine clinic at the Franklin Senior Center sometime in November.

Mr. Ursin had nothing to report.

OPEN PUBLIC SESSION

Mr. Snyder made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Skellenger. All were in favor.

Mr. J.R. Giacchi, Franklin Borough School Superintendent, stepped forward. Mr. Giacchi voiced concerns regarding Resolution 2022-75. Mr. Giacchi explained the 2% cap and how it would affect the school board. Mr. Giacchi would like to work together before passing this resolution. Mr. Giacchi commented that the School

Board has replaced windows, installed a more efficient boiler and ran natural gas to the building which is all cost savings. Franklin Borough School has no debt and we would like to work together for a year to see how it goes.

Mr. Wayne Bartron, 21 Hemlock Drive, Franklin, stepped forward. Mr. Bartron voiced his concerns about something as big as this being moved without any communication with the Board of Education. He would like to see all the elected officials working together. As a taxpayer, his concern is that the turnout in April isn't worth moving it back. He is asking, as a taxpayer, that the resolution be rescinded, open up the line of communication and revisit this next year.

Mr. Shane Hrbek, 343 Rutherford Avenue, Franklin, stepped forward. Mr. Hrbek commented on the costs for moving the election to April and would like to see the resolution rescinded.

Mrs. Sarah Zydon, 346 Rutherford Avenue, Franklin, stepped forward. Mrs. Zydon voiced her displeasure with the Council regarding Resolution 2022-89 and the lack of communication. Mrs. Zydon asked that the Council work with the School Board.

Mr. Cliff Graham, 5 Master Street, Franklin, stepped forward. Mr. Graham voiced his concerns with regards to resolution 2022-89 and that he does not support the resolution.

Mr. William VanTassel, 28 Nestor Street, Franklin, was granted permission to join the meeting after raising his hand on ZOOM. Mr. VanTassel clarified that this resolution is just a public question to go on the ballot asking voters if they want to move the election.

There being no one else present who wished to address the Governing Body, Mr. Skellenger made a motion to close the meeting to the public, seconded by Mrs. Heath. All were in favor.
