Mayor Sowden called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mrs. Carnes, Mr. Formica, Mrs. Heath, Mr. Limon, Mr. Skellenger, Mr. Snyder and Mayor Sowden.

Absent: None

Mayor Sowden led the assembly in the flag salute.

Mayor Sowden stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and printed in the New Jersey Herald/Sunday New Jersey Herald on January 12, 2025, and posted on the Borough website, which adequate notice has been certified by the Clerk."

PRESENTATIONS

Mr. Michael Christensen stepped forward to discuss his Eagle Scout Project. Mr. Christensen thanked Mayor Sowden for emailing him the names for the Eagle Scout Project. Mr. Christensen requested a change in the timeline of his project. Mr. Christensen commented that he has a deadline of May 19, 2025. Mr. Christensen asked if he could make the structure of the project and add the names later on. Mr. Christensen needs the approval of the beneficiary for any changes. Mr. Christensen needs permission to say that the structure is the project.

The consensus of the Governing Body was to approve the change in the project.

Ms. Jessica Caldwell provided the Governing Body with some background for the resolution on Affordable Housing.

Historic Designation

Pete Olieman, Van Cleef Engineering stepped forward. Mr. Olieman commented that a result of the reconstruction of the Franklin Via Duct, a wetlands permit was needed and one of the conditions of a wetlands permit is that you cannot have an adverse effect on a historic district or potential historic district. Mr. Olieman commented that they had Tom Jones evaluate the area around the bridge, the bridge itself and eventually most of the Borough to see exactly what was potential and that led to a condition of the permit relating to the historic district. Replacing the bridge had an adverse impact on the historic district/potential historic district. In remediation for that we introduced elements into the bridge to make it more compatible with the district.

Mr. Tom Jones, Historic Preservationist, stepped forward. Mr. Jones commented that through the decades of his career in doing section 106 compliance throughout the Mid-Atlantic states and other parts of the Country, its rare when a potential historic district meets all the national register criteria. Franklin did do that which was determined by the New Jersey State Historic Preservation Office. Mr. Jones commented that what he suggests here; is that there is something extremely unique and valuable and could add to the economic health of the community and the area by increasing tourism.

Mr. Matt Sinke, County of Sussex Assistant Engineer, stepped forward. Mr. Sinke explained the process to submit the Historic Register Nomination Application.

Mrs. Heath asked if this was just for the bridge.

Ms. Jessica Caldwell stepped forward. Ms. Caldwell commented on the various layers of the districts create. There is essentially three layers, Federal Designation, State Designation and a local designation. In her opinion, the Federal and State Designations, essentially, are very similar and create the same type of requirements and overlays. The State and Federal Designation would essentially designate the

area but would not create local requirements. When it kicks in, in terms of any kind of regulatory review, is essentially similar to what happened when the viaduct was put in where you got a section 106 review, which is an environmental impact statement type of review. As far as Federal or State district it does not impact a local homeowner. As far as benefits go, there is eligibility to apply for grants (both State and Federal) and also eligibility to use federal tax credits for improvements to properties within the district. There are some incentives and ability to access funding for projects within a State or Federal designated Historic District.

Mr. Jones commented that it is not unusual for the general public to not be clear; just getting listed on the national register does not restrict their private property rights.

Ms. Caldwell commented that the planning board did review this and passed a resolution in December supporting the designation.

Mr. Formica asked how do you get out the historical designation, if you so choose to.

Mr. Jones commented that the resource disappears.

Mrs. Carnes asked what if a particular property owner did not want to be involved in this designation, is there a way they can opt out of it.

Mr. Oliemen commented that for the national register there is no restrictions. It is when a local ordinance is developed based on adopting the master plan element then it would go through that process.

Mr. Jones commented to further answer your question, if Franklin wants to pursue this. Very important in the process is input from the property owners within the boundaries of the historic district. A letter must go out asking their opinion if they would like to be listed on the national register. That is taken into very serious consideration in Trenton. If the majority of the residents do not want to be listed on the national register there had been precedence where the state historic preservation offices around the country are gone.

Ms. Caldwell commented that under the section 106 review it states that it is required if it is a historic or eligible to be a historic district. So, if this is submitted to the State Historic Preservation Office in Trenton, does that not get triggered either way.

Mr. Sinke commented that regardless of the action by this Council, we package up the nomination package and send it to the NJ State Review Board. NJ State Review Board and State Historic Preservation Office review the nomination and they may give us comments back we would then have to address and then they will decide how to move forward with it. If they decide that they are going to move forward with it, there will be a process whereby all property owners will need to be notified within the potential district.

Mr. John Christiano, Planning Board Chairman, stepped forward. Mr. Christiano commented that the Planning Board held their meeting on December 4, 2024 to review the proposal and ultimately voted in favor of it but not until after we heard from the gentlemen from Van Cleef Engineering and Mr. Jones. The members of the Planning Board saw a very specific value in the presentation that was given. Part of it was tax incentives that are available to the home owners if they want to restore their home to a historic exterior. There are also grants available. Again, nobody being under any obligation to do this but if they decided to go ahead there is money to be found. One thing that raised Mr. Christiano's eyebrow was when Mr. Jones mentioned the possibility of Franklin becoming a UNESCO (United Nations Educational Scientific and Cultural Organization) site. Things that are designated UNESCO heritage sites are pyramids of Egypt, the Eiffle Tower, Notre Dame and Roman ruins in Rome. If you are designated a UNESCO site you are playing with the big boys, you have world wide recognition of who you are and what happened. Franklin checks off a lot of the boxes for an internationally recognized site. There are no obligations to any homeowners here.

Mr. Formica commented that he feels there needs to be a little bit more clarification regarding the State and National Register not impacting homeowners however it does expand the area that will be deemed under historic which can then be determined by the Planning Board and the Historical Commission.

Mr. Christiano commented that his understanding is that the map is not an optimized map and if there are areas here that we, as a town, decide really do not belong in there we have the authority to reduce the designated area.

Mr. Jones commented that you can negotiate with the State Historic Preservation Office.

Mr. Christiano asked if the agenda for tonight's meeting was published and if the question of Historic Designation.

Mayor Sowden commented that the agenda was posted and that a presentation was on the agenda for the Historic Preservation.

Mr. Christiano commented that what he would recommend is, we could go two ways with it, you could have a referendum where the town actually votes on it or we announce a public meeting where the question can be put before the public.

Mr. Formica asked why this was not done for the Planning Board. It was a last minute email that went out right before Thanksgiving that stated you were going to do a presentation, apologized for the last minute notice that we were going to have a presentation and workshop meeting which was not advertised as far as the workshop meeting or what was going to be on the agenda. It was presented and voted on without only specific audience that were somehow told about it but the general public that was affected by it and now here we are at a second meeting with a second presentation and the people that live in this area were still not notified.

Mr. Christiano commented that first of all the vote we took was a recommendation it was not an action. It was not an action to designation this area. It was a recommendation that we agreed to and we agreed to send it to the Council where the ultimate vote would take place. The ultimate vote did not take place with the Planning Board. So, whether the Borough was aware of it or the public was aware of it or not is really material since we had no control over the final vote.

Mr. Formica commented that it is one of the steps in the process, is a recommendation from the Planning Board, a recommendation from the Historic Commission to go before the Council and the Council would then vote to either adopt the designation or not.

Mrs. Carnes commented that if a person receives a letter at their house, they are more apt to respond to it as opposed to whether it is placed on social meeting.

Mr. Formica commented that if we are going to move forward with anything the public needs to be notified.

Mr. Phil Crabb, Chairman of the Historic Committee stepped forward. Mr. Crabb commented that it is highly remarkable that Franklin has met all 4 criteria. Whether we do our historical designation or not, we are going to be subject to historical review with regards to any major capital project that we do here.

Mr. Matt Sinke commented that the requirement from the County's perspective is to prepare this application and submit it to the State. State Historic Preservation Office website has more information on the application process.

Mayor Sowden commented that he realizes the seriousness of this and he wants everyone to have the time to absorb this information to make the right decision. This is why he is not saying anything about a resolution tonight, I just want to educate the Council to get them up to speed so that they are aware of what they are working on and what they may vote for or not. That was the intention of this meeting.

COMMITTEE REPORTS

Mrs. Heath commented that she did not attend the Reorganization of the Recreation Committee however, Bobbi Formica is the Chairperson and Fred Babcock is Co-Chair. Mrs. Heath commented that the Rifle Club received the outstanding club award.

Mr. Skellenger commented that the Mobile Unit from the Motor Vehicle Commission will be in Franklin on March 29, 2025. They will be doing real id, registration renewal, duplicate titles and handicapped placards. Appointments will open up a month before.

Mr. Formica commented that the Ordinance Committee met along with Zoning and the Court to discuss adding additional sign throughout the Borough for snow and parking ordinance. We also discussed modifying the sign ordinance to allow digital signs. Mr. Formica spoke with Jesse and he ordered the water coolers and they will be installed soon.

Mr. Limon commented that we are at the final stages of the public works contract. There was a public works meeting and discussed some items. There was a historic committee meeting and the chairman swore in a few members on the board. Mr. Limon wants to let everyone know that it was 100% support on the historical designation.

Mrs. Virginia Littell stepped forward. Mrs. Littell commented that you as elected to sit on the Council, you represent, not just where you live, you represent everyone that lives in this municipality. We have something here that is so unique and so fabulous and to say that people will not be announcing it in a letter, you get letters for everything from a municipality. Mrs. Littell believes that it is so important for the future of our municipality, in a global perspective. Mrs. Littell commented that she is so excited that the governing body who have been elected by all of us in this municipality are going to have the opportunity to embrace something that is so unique in the world.

Mrs. Judy Williams stepped forward. Mrs. Williams commented that this is incredible that we qualify and that we have it. Mrs. Williams commented that if we talk about homeownership and talk about people, do you know how many homes and

WHEREAS, the sunset provision of March 1, 2025 imposed under P.L. 2024 c.106 is fast approaching in what was a temporary solution that allowed local governments to comply with the notice requirements under the law in time for annual reorganization meetings in January; and,

WHEREAS, local government officials serve as the stewards of property taxpayer dollars and should no longer be required to subsidize the newspaper industry with revenues collected from publishing legal notices in the press; and,

WHEREAS, long before NJ Advanced Media’s announcement that it was terminating daily print publications in January of 2025, local government officials found it increasingly difficult to comply with the notice requirements under the law as the media has become almost exclusively digitized and struggled to retain staff, resources, and publications; and,

WHEREAS, legislation that will authorize local governments to publish legal notices on a local government’s official website will streamline an antiquated and overly burdensome process and save valuable time, resources, and property taxpayer dollars; and,

NOW, THEREFORE, BE IT RESOLVED that the Borough of Franklin does in fact, hereby urge state leaders to pass legislation that will authorize counties, municipalities, school districts, and all local governments to publish legal notices in a clear, transparent, and timely manner on a local government’s official website.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be sent to Governor Phil Murphy, Senate President Nicholas Scutari, Speaker of the General Assembly Craig Coughlin, and the clerks of the boards of county commissioners in all twenty-one counties.
