WHEREAS, the Purchasing Agent has recommended the contract be awarded in the amount not to exceed \$19,250.00 and,

**WHEREAS** the Chief Financial Officer certifies the availability of funds and that the funds shall not exceed \$19,250.00

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of Franklin, County of Sussex, State of New Jersey, as follows:
