### **RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING THE AWARD OF A REQUIRED DISCLOSURE CONTRACT OVERCOAT LLC**

**WHEREAS**, the Borough of Franklin has a need for a business development consultant, and Overcoat, LLC of 4 Lower Hill Road, Newton, NJ 07860, has a required disclosure contract under the provisions of N.J.S.A. 19:44A-20.4et. Seq., and,

**WHEREAS**, the Qualified Purchasing Agent has certified that the value of the contract is more than the Pay to Play threshold of \$17,500.00; and

**WHEREAS**, Overcoat, LLC of 4 Lower Hill Road, Newton, NJ 07860 has supplied a quote for:

- Business Development Consultant not to exceed \$20,000.00

**WHEREAS** Overcoat, LLC is deemed to be the most advantageous to the Borough based upon Price and other Factors per N.J.S.A.40A:11-6.1 et. Seq., and

**WHEREAS**, Overcoat LLC has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form, which certifies that the entity has not made any reportable contributions to a candidate in the Borough of Franklin in the previous year and that the contract will prohibit the entity from making any reportable contributions through the term of the agreement, and

**WHEREAS**, the Purchasing Agent has recommended the contract be awarded in the amount not to exceed \$20,000 and,

**WHEREAS** the Chief Financial Officer certifies the availability of funds and that the funds shall not exceed \$20,000

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of Franklin, County of Sussex, State of New Jersey, as follows:

1. That the contract be and hereby is awarded for a business development consultant not to exceed \$20,000.00 to Overcoat, LLC of 4 Lower Hill Road, Newton, NJ 07860
2. That the cost for the services aforesaid shall not exceed \$20,000.00
3. That the Municipal Clerk shall forward a certified copy of this Resolution to the following:


