RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING THE AWARD OF A REQUIRED DISCLOSURE CONTRACT TO GRIDLESS POWER FOR THE FRANKLIN POLICE DEPARTMENT

WHEREAS the Borough of Franklin Police Department has a need for a video and an access control system for their headquarters, and Gridless Power 7905 Browning Road, Suite 104, Pennsauken, NJ 08109, has a required disclosure contract under the provisions of N.J.S.A. 19:44A-20.4 et seq. Seq., and,

WHEREAS, the Qualified Purchasing Agent has certified that the value of the contract is more than the Pay to Play threshold of \$17,500.00 and

WHEREAS Gridless Power 7905 Browning Road, Suite 104, Pennsauken, NJ 08109, has supplied a quote for:

WHEREAS Gridless Power has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form, which certifies that the entity has not made any reportable contributions to a candidate in the Borough of Franklin in the previous year and that the contract will prohibit the entity from making any reportable contributions through the term of the agreement, and

WHEREAS, the Purchasing Agent has recommended the contract be awarded in the amount not to exceed \$52,855.09 and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of Franklin, County of Sussex, State of New Jersey, as follows:

1. That the contract be and hereby is awarded for video and an access control system to Gridless Power 7905 Browning Road, Suite 104, Pennsauken, NJ 08109
2. That the cost for the services aforesaid shall not exceed \$52,855.09
