### **RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING A CONTRACT FOR THE PURCHASE OF A FOUTS 4 MINI-PUMPER FIRE TRUCK**

**WHEREAS**, the Borough of Franklin wishes to purchase a Fouts 4 Mini-Pumper Fire Truck from FF1 Apparatus under the HGAC Cooperative Purchasing Contract #FS12-23 and,

**WHEREAS**, the purchase of goods and services by local contracting units is authorized by Local Public contracts, **N.J.S.A. 40A:11-12**; and,

**WHEREAS**, FF1 Apparatus is an authorized Fouts dealer under the HGAC Cooperative Purchasing Contract #FS12-23 and

**WHEREAS**, the Purchasing Agent has recommended the utilization of this contract because it represents the best cost savings to the Township; and,

**WHEREAS**, the Borough Council is satisfied with the recommendation offered by the Purchasing Agent; and,


**WHEREAS**, the cost for the HGAC Contract purchase of Fouts 4 Mini-Pumper Fire Truck shall not exceed the total amount of \$415,200.00 and,

**WHEREAS**, the contract award aforesaid shall be conditioned upon the certification of funds by the Chief Financial Officer.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Franklin, County of Sussex, and State of New Jersey as follows:

1. That a HGAC Contract purchase of a Fouts 4 Mini-Pumper Fire Truck does not exceed the total amount of \$415,200.00
