Mrs. Carnes commented that two new businesses have opened up in the past couple weeks. One is Holy Chick and the other is the Korean BBQ Chicken place.

We talked about the few roads from Walsh up to Ridgewood; about doing that section over. We talked about looking for grant opportunities for the salt shed, continuing improvements around town and replacing the Christmas lights on Main Street. Everyone should have received an email regarding a swearing in ceremony and recognition of other police officers on Thursday at the firehouse. Mr. Formica asked to invite the first aid to the reorg meeting for swearing in.

Mr. Spidaletto commented that we are going to need to table the discussion on the shared services with Lafayette. Franklin was a recipient of the Drive Sober or Get Pulled Over grant in the amount of \$7,000; we did get awarded the State DOT grant for 2026 \$444,652 for road improvement projects which includes the roads Kovach, Mabie and South Street. We are teeing up with the public works committee for next year early spring on the 2025 State DOT grant we received in the amount of \$148,284 for the roads of Master, Warren and Green Streets.

Mayor Sowden commented that last night there was a planning board meeting and discussed the Ryan Homes project. Mayor Sowden agrees about replacing the lights on Main Street. The Planning Board did have a quick discussion on the

historic designation and the two ordinances for open space and mapping. Mayor Sowden wanted to know how the council felt about clearing out the trees that fell in the cemetery on Oak Street. Mayor Sowden asked if we are still working on doing something for the 250th anniversary.

Mrs. Tatka commented that the laundromat wanted 18 spaces in the parking lot and asked if they were getting those spaces.

RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, ESTABLISHING THE BID THRESHOLD

WHEREAS, effective July 1, 2025, the Governor of the State of New Jersey has adjusted the bid threshold for awarding contracts under the Local Public Contracts Law. The change in the bid threshold allows municipalities with a Qualified Purchasing Agent to increase their bid threshold up to \$53,000 and

WHEREAS N.J.S.A. 40A:11-3a permits an increase in the bid threshold if a Qualified Purchasing Agent is appointed as well as granted the authorization to negotiate and award such contracts below the bid threshold and

WHEREAS N.J.A.C. 5:34-5 et seq. establishes the criteria for qualifying as a Qualified Purchasing Agent and

WHEREAS Robert M. Dolan of RMD Associates LLC was appointed the Borough of Franklin Qualified Purchasing Agent by the adoption of Resolution 2026-14 and possesses the qualifications and designation of a Qualified Purchasing Agent License #Q-1742 as issued by the Director of Local Government Services per N.J.A. C. 5:34-5 et seq.; and

WHEREAS the Brough of Franklin desires to establish the bid threshold to \$53,000.00 per N.J.S.A.40A:11-3a.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Franklin, County of Sussex, State of New Jersey, as follows:

1. The bid threshold is hereby increased to \$53,000.00 effective July 1, 2025 consistent with the New Jersey Local Publics Contract Law.
2. That the Chief Financial Officer is authorized to adjust bid and quote levels to reflect the new thresholds in applicable purchasing policy
