RESOLUTION OF THE BOROUGH OF FRANKLIN AUTHORIZING A CONTRACT FOR THE PURCHASE OF A 60X40 METAL FABRIC ROOF BUILDING ON A NATIONAL COOPERATIVE CONTRACT

WHEREAS the Borough of Franklin wishes to purchase 60x40 Cold Form Metal Fabric Roof Building materials from Hawkeye Steel Products/Elemental Shelters under the Sourcewell Cooperative Purchasing Contract #071223-HWK and,

WHEREAS the purchase of goods and services by local contracting units is authorized by Local Public Contracts, N.J.S.A. 40A:11-12; and,

WHEREAS, Hawkeye Steel Products/Elemental Shelters is an authorized dealer under Sourcewell Cooperative Purchasing Contract #071223-HWK and

WHEREAS, the Purchasing Agent has recommended the utilization of this contract because it represents the best cost savings to the Borough; and

WHEREAS, the governing body is satisfied with the recommendation offered by the Purchasing Agent; and

WHEREAS, the cost for the Sourcewell Contract purchase of a 65x40 Cold Form Metal Fabric Roof Building materials shall not exceed the total amount of \$104,372.05, and
